

# **Jia Yin Academy Ltd. Waiver & Release Agreement**

## **1. Voluntary Participation & Assumption of Risk**

By choosing to participate in classes, performances, workshops, and other activities at Jia Yin Academy Ltd. ("JYA"), I acknowledge that my participation is voluntary. I certify that I am in proper physical condition to engage in these activities. If I have concerns about my suitability for any activity, I will consult a healthcare provider before participating. Additionally, if I have any known physical conditions, vulnerabilities, or injuries, I agree to discuss them with the instructor prior to participation.

## **2. Release of Liability**

By agreeing to this waiver, I release, waive, and discharge Jia Yin Academy Ltd., its directors, owners, students, teachers, staff, employees, and volunteers (collectively referred to as "JYA") from any liability or claims related to bodily injury, personal injury, illness, death, or property damage arising from my participation in JYA activities.

I voluntarily waive my right to sue or hold JYA responsible for any injuries, damages, or losses resulting from:

- Participation in dance, theatre, or vocal classes, intensives, workshops, performances, or troupes.
- Use of JYA equipment, facilities, or engagement in any JYA-related activities.

## **3. Assumption of Risk & Hands-On Instruction**

I acknowledge the inherent risks involved in dance, theatre, and vocal training, including but not limited to:

- Slips, falls, sprains, strains, and dislocations.
- Soft tissue injuries, musculoskeletal injuries, and foot conditions.

Despite these risks, I choose to participate at JYA. Additionally, I understand that dance education may involve hands-on instruction, where instructors may adjust my arms, legs, feet, hips, back, and head for correct positioning. If I have concerns about physical adjustments, I will communicate them clearly to my instructor or the director.

## **4. Medical Treatment & Insurance**

I understand that JYA does not provide medical, health, or accident insurance. If I become injured or ill during participation, I acknowledge that JYA is not financially responsible for medical costs.

In case of emergency, I authorize JYA to seek necessary medical treatment on my behalf, including first aid, ambulance transport, hospitalization, or other care. If my insurance does not cover these costs, I accept full financial responsibility. I release JYA from any claims related to emergency medical decisions made on my behalf.

#### 5. Photographic & Media Release

I acknowledge that JYA may take photos and videos of participants during classes and activities. I grant JYA full rights and ownership of these recordings for use in advertising, promotional materials, and other digital or print publications.

If I do not consent to being photographed or recorded, I will:

- Notify the teacher or director in advance.
- Take proactive steps to avoid being in photos/videos.
- Understand that this may limit my participation in performances that are routinely documented.

If JYA has taken reasonable precautions but my image is still recorded and released, I agree to hold JYA harmless from any claims.
