I researched three different bike racks and presented the options to the Board at our Nov. 2nd Board Session Meeting. We all agreed on the mid-range priced bike rack. I want to thank Jerry Joslin and Julio Trausch for helping me to dig the holes and anchor our brand new bike rack that is just south of the bench at the school bus stop. #### **Reconfigured Access to Community Well Head Pipe**

Our community well had an antiquated and awkward well head pipe hose access that has been damaged several times. To prevent this from occurring again and to prevent more future repair bills, I designed a reconfiguration that lowers and protects the well head pipe access. #### **Post Office Request for Additional Mail Receptacles**

The Post Master recently requested a meeting with me and Lavender F. to discuss the need for another bank of mail slots due to increased development of new residential properties in Sherwood Forest. The Post Master cited Postal Operations Manual 632.11 which reads that the purchase, installation and maintenance of mail receptacles are the responsibility of the Customer (Common Interest Community/HOA/Property Management Company). We are negotiating with the Divide Post Office for the most efficient and economical solution to these requirements and should be able to provide more details at our January semi-annual meeting.



#### November 2nd, 2017 Board Session

This was the first meeting of the Board since the July semi-annual meeting and after the August Robin Hood Dash-n-Dine 5K. The first topic was a discussion with regard to the Post Office request to add another bank of mail box slots to accommodate newly developed residential properties in Sherwood Forest. The Post Office will provide S.F.I.A. the official documents detailing the responsibilities of Common Interest Communities and mail receptacles. The Board agreed that Corry S., Lavender F. and Catherine D. can make the appropriate arrangements with the Post Office that will both satisfy S.F.I.A. responsibilities and also be the most economical solution for us. Corry S. then reported on his work for the reconfiguration of access to the community well head pipe to prevent future damages from careless handling of the hose or from kids swinging on it. The next topic was a presentation of three different bike racks Corry S. found on the Internet. The Board decided on the middle range priced one, and Corry S. and Jerry J. will try to get it installed at the bus stop soon after it is delivered. Next, the Board discussed the summer fundraiser article by Julie N. and agreed it should be in the December Newsletter. There was a discussion about needing more community help both with the planning of any future fundraising events and also with actually accomplishing projects with the funds if we are to continue to host these annual events. Lisa J. agreed to format our December Newsletter and coordinate the mailing with Shipping Plus. The Board agreed to include another invoice for dues to encourage community members to support S.F.I.A., and also to offer new community members an opportunity to join our organization.
