Semi-annual meeting: We will be having our Semi-Annual Community Meeting July 18th, 2021 @ 1:00 in the Community Clubhouse. We missed seeing everyone in January and hope that you will be able to join us on the 18th!

Hall renovations: At our 9/15/20 board meeting we allocated \$2000 for hall maintenance and renovations. We hired painters for the exterior trim, and they did a nice job at a very fair price of \$1300. They have submitted an estimate to paint the interior (\$1499). Jean Miller generously purchased the paint for that project. Jean also purchased new lights and curtains. Dan Crown installed the lights. We also agreed to keep the hall open during the winter months in hopes that more community members would choose to use the hall for their gatherings.

Member input: Hiring out for the interior painting would obviously be a large portion of the available budget, leaving little left for further improvements and upgrades that need to be made. This is your hall, folks, and we need to hear from you! We have been discussing the possibility of marketing the hall to the general public at higher than current rental rates as a source of much needed revenue. Renovations are essential before we can do that.

We would also like to have a "Grand Reopening" to showcase the hall.
