### **Payment Requirements:**

FULL PAYMENT FOR SERVICES & MERCHANDISE BEFORE CREMATION OR BURIAL ARE REQUIRED

Prices may change without notice; please see website for current prices. We accept all major credit cards with a 3% convenience fee.  
We also accept Checks, Cash, Venmo or Zelle payments with no extra fees.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

"The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected."

### **Basic Services of Funeral Director and Staff \_\_\_\_\_ \$895**

Our fee includes, but is not limited to staff and facilities to respond to the initial request for service; consultation with the family or responsible party; coordinating services plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased; and/or arrangements for military burials at a National Cemetery if applicable; preparing and filing of required authorizations, death certificate and permits; and sheltering of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. *(This fee is already included in our charges for our Direct Cremation Package, Immediate Burials, Forwarding or Receiving remains)*

### **Embalming/Not Posted \_\_\_\_\_ \$600**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial.

Without formal services/no preparation of the body. Immediate family up to 5 members for 20 mins.

**DIRECTING SERVICES** Our services include coordinating the arrangements and supervision of services, equipment needed for ceremony and set-up of casket, display of floral tributes and staff to assist with ceremony.

Facility and Church fees not included.

**Direct Cremation** **\$895**

(If the deceased weighs more than 249 lbs, there are extra crematory fees. **Additional \$170.00 - for 250 lbs. to 349 lbs., for 350 lbs to 499 lbs., additional \$1.60 per pound - for 500 lbs., additional \$1.85 per pound**) Our direct cremation includes all the basic professional services, as well as provides for the transfer of your loved one from the place of death to our secured facility. Once in our care, your loved one will be placed in refrigeration. This does not include any rites or ceremonies. We will then deliver the cremated remains to you in a black plastic container or a purchased urn within 30 mile radius in San Diego county. The containers we provide are rigid cardboard container, as required by statute. **Use of an alternative container requires cremation fee of \$150 in addition** to the cost of the alternative container, see Casket Price List. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or other composition materials (with or without an outside covering).

**Forwarding of Remains to Another Funeral Home** **\$2,833**

Our forwarding is a partial service package that includes all the basic professional services, necessary authorizations, one death certificate and county transit permit as well as provides the transfer of your loved one from place of death to our secured facility. Once in our facility we will arrange to have your loved one embalmed and prepared for shipping. Upon coordination with your receiving funeral home, we will transfer your love one in a shipping container to San Diego Airport within the U.S. continent. (This does not include a casket, airline shipping charges, dressing, cosmetics, visitation and local ceremonies or the receiving funeral home expenses)

**Receiving of Remains from Another Funeral Home** **\$1,645**

Our receiving is a partial service package that includes all the basic professional services, refiling the burial permit, immediate burial as well as provides the transportation of your loved one from San Diego Airport to our secured facility. Upon coordination with cemetery, we will transport your loved one in our Van to the cemetery within 30 mile radius; **additional distance will be charged \$4.00 per mile.** *(This charge does not include use of a facility and staff for visitation/viewing or funeral ceremonies)*

**Immediate Burial - Without Services or Ceremony** **\$2,295**

Our immediate burial package includes all the basic professional services as well as provides for the transfer of your loved one from the place of death to our secured facility. Once in our care, your loved one will be placed in refrigeration and we will arrange to dress and prepare the body. We will transport your loved one to the cemetery in a Van within 30 mile radius in San Diego county, additional distance will be charged \$4.00 per mile. Casket provided by the purchaser and all such casket must meet applicable State or cemetery requirements. *(This charge does not include use of a facility for viewing/visitation, any rites or ceremonies at the graveside or elsewhere)*
