All Commissioners of Oaths on Oaths.co.za operate under the authority of:

- Justices of the Peace and Commissioners of Oaths Act, 1963
- GN R1258 of 1972 Regulation 10
- Electronic Communications and Transactions Act, 2002 (Sections 11–15, 18 – legal validity of electronic records, signatures, and trust services)

What Our Commissioners Are Authorised to Do

Commissioners registered with Oaths.co.za are authorised to:

- Certify true copies of original South African documents:
 - Smart ID Cards
 - Driver's Licences
 - Passports
 - Proof of Address (PDF only)
- Operate entirely within the Oaths.co.za digital platform
- Certify only what is legally permitted
- No affidavits, affirmations, or declarations are allowed. These fall outside the legal scope of Regulation 6 and require in-person witnessing.

What Qualifies a Commissioner of Oaths for Oaths.co.za

To be accepted as an Approved Commissioner of Oaths on Oaths.co.za, a candidate must:

- Be duly appointed in terms of South African law
- Be in good standing with a recognised professional body, such as:
 - SAIPA (Professional Accountant (SA))
 - SAICA (CA(SA))
 - IRBA (Registered Auditor)
 - Legal Practice Council (Attorney or Advocate)
 - Or any other regulator recognised by Oaths.co.za
- Not charge any fee for the act of certification, in accordance with Regulation 6 of GN R1258 of 1972

How Oaths.co.za Vets Its Commissioners

Every Commissioner on the platform undergoes strict vetting and onboarding, including:

- Face-to-face onboarding at Beantech offices or a digitally recorded verification session
- Mandatory submission of:
 - South African Smart ID Card
 - Proof of current professional membership
 - Valid SARS Tax Compliance Status
 - Recent Proof of Address
- Upon approval, each Commissioner receives a unique platform token to perform secure digital certifications

What the Oaths.co.za Platform Does

The platform handles all technical, forensic, and compliance operations on behalf of the Commissioner:

- Biometric identity & liveness checks (video or camera-based)
- Forensic validation of document authenticity
- Automated system compliance controls
- 2048-bit encrypted digital signatures (Adobe Pro trusted)
- Blockchain hash & unique QR code generation per certification
- PEP, PIP, and sanctions screening for every session
- Tamper-proof audit trail digitally signed, timestamped, and stored securely

Note: Commissioners cannot upload any documents, and can only proceed with signing once the system verifies that all legal, biometric, and compliance checks are fully greenlit.
