As per Regulation 6 of GN R1258 of 1972, the act of certification is free of charge.3 Your subscription fee covers the use of our advanced digital infrastructure, which includes identity verification, secure cloud storage, and automated compliance tools.4

2. Eligibility

To use the platform, you must be:

- o At least 18 years old.²
- A South African citizen with a valid Smart ID Card.²
- o In possession of a valid South African Smart ID Card.²
- o Acting on your own behalf, and not using another person's documents.²

3. Subscriptions and Payment

- Subscription fees apply for access to the platform and its associated services.
- o Certification itself is free, as required by law.
- o All prices are inclusive of VAT and payable annually in advance.
- Refunds: If your account is disqualified for legal or verification reasons, no refund will be applicable due to processing costs.²

4. Certification Disclaimer

Document certification is carried out solely by an appointed Commissioner of Oaths who operates under their personal legal responsibility. Our platform supports this process with technology that ensures a high level of legal and document integrity. The verification process, which includes biometric checks, government record validation, and a blockchain audit trail, gives the certified documents a superior level of

evidentiary weight under South African law.⁶ While Oaths.co.za provides these security measures, institutional policies regarding the acceptance of digital documents may vary.⁷

5. User Responsibilities

You agree to:

- Provide truthful and accurate information.²
- Keep your account credentials secure.²
- o Only upload your own, valid documents.²
- Use the platform only for lawful and legitimate purposes.²

6. Prohibited Use Policy

Oaths.co.za complies with the Protection of Personal Information Act (POPIA), 4 of 2013.2 Your data is encrypted and stored on Microsoft Azure infrastructure. Compliance screening includes AML, PEP, and sanctions databases. Your continued use of the platform confirms your lawful intent and informed consent.

Beantech (Pty) Ltd is not liable for any third-party rejection of digitally certified documents, service interruptions, or damages arising from user error or misuse of the platform.2 The platform is provided "as is" and its use is entirely at your own risk.
