## **Car Seats**

As a reminder, effective 1/1/17, the following are the California laws regarding the use of car seats:

- A. Children under 2-years old must be rearfacing unless they weigh 40 pounds or more, or are 40 inches tall or more.
- B. Children under the age of 8 must be secured in a car seat or booster seat in the back seat.
- C. Children who are 8 years of age OR have reached 4'9" in height must be secured by a safety belt.
- D. Passengers who are 16 years of age and over are subject to California's Mandatory Seat Belt law.

Additionally, the KBYH expectations for transportation includes all drivers must:

- 1) Have a valid California driver's license.
- 2) Carry evidence of current liability insurance for at least the minimum amount prescribed by state law and proof of vehicle registration.
- 3) Maintain the vehicle in safe mechanical condition as required by law.
- 4) Have an available seat belt for each child in the vehicle and have the capacity to transport all children residing in the home.
- 5) Will refrain from ever leaving a child alone in a car.
- 6) Will refrain from smoking in any vehicle that may be used for the transportation of a child or nonminor dependent.
- 7) Will not permit any child or nonminor dependent to be transported by a person known or reasonably known to not have a valid driver's license.

# **KBYH Cell Phone Policy**

After much consideration, KBYH has adopted the following policy. We believe that all youth need a cell phone, with a long-term phone number, in order to compete and succeed in school, work, and with their peers. The following is effective 9/1/19:

Unless prohibited by court order or the person or agency responsible for placing the child, any foster child may acquire, possess and use his or her own cell phone. Although the law does not require Resource Parents to purchase or pay for phone service for a foster youth, it also does not forbid it. Therefore, KBYH has determined that in keeping with providing normalcy for foster youth\*, all resource parents approved through KBYH will be required to adhere to the KBYH Cell Phone Policy that does require resource parents to purchase a cell phone and pay for ongoing services as part of our program, per the following guidance:

- 1) Foster youth should have a cell phone by at least the age of 12.
- 2) A cell phone should be acquired within 4 weeks of placement, assuming that the placement will be ongoing for at least the immediate future
- 3) The cell phone and plan should be purchased by the Resource Family using foster care funds paid to the Resource Family (currently (7/19) \$1,000-1,337 per month) and not with the youth's allowance. Purchasing low cost phones and low priced, no contract plans is acceptable, but it is assumed an initial phone and plan will cost a minimum of \$85 and the ongoing minimum month-to-month cost will be at least \$35. In addition to these minimums, foster youth can opt to use allowance to help towards the purchase of an upgraded plan or cell phone (provided the Resource Family and youth both agree to the terms). Additionally, the Resource Family will purchase a reasonably priced case for the phone.
- **4)** KBYH and the KBYH Resource Families assume no liability for the cell phone. If it is stolen, confiscated, damaged, or lost, it will be the responsibility of the foster youth, using allowance or other earnings, to replace the phone (if they so choose).
- 5) If a foster youth has a cell phone at the time of admission, the Resource Family will not be obligated to the terms of that cell phone's existing plan.
- **6)** Foster youth have the right to privacy; therefore, resource parents do not have the right know the password to the cell phone and/or review the contents of the phone unless approved by an authorized representative (county social worker, attorney, court system, etc.).
- 7) It is recommended that youth be able to maintain the same cell phone number over the course of time, regardless of where they are placed. As such, Resource Families are discouraged from adding a foster youth to their family cell phone plan as this can make it difficult for the youth's phone number to be portable.
- **8**) Resource Families may restrict use of the cell phones per reasonable house rules, which should be explained and in writing prior to provision of the cell phone.
- **9)** Non-minor dependents have the personal right of acquiring, possessing, and using their own personal cell phone with limited restrictions that should be detailed in the shared living agreement.



- **10)** Foster youth that leave the resource home should maintain possession of the cell phone and provision should be made by the Resource Family for one month's service to continue post-discharge. After which, Resource Families do not have an obligation to maintain the cell phone plan.
- 11) If at any time better cell phone options become available for foster youth, KBYH will reconsider this policy and the requirements therein.

#### \*Providing Normalcy for California Foster Youth

Young people in foster care often lack access to many of the everyday experiences and activities available to their non-system involved peers. Research demonstrates that "normalcy" is essential for healthy social, emotional, and cognitive development of young people. "Normalcy" is also important in supporting youth in care to achieve permanency – lifelong connections with committed and caring adults. However, system imposed barriers often impede the ability of youth in care to have normal relationships with family and friends inside and outside of the system, participate in extracurricular, enrichment or social activities, or experience many of the milestones non-system involved peers take for granted. Liability, confidentiality and other system concerns condition county placing agencies to impose barriers that prevent youth in care from accessing and participating in team sports, overnight field trips, proms, driver's education, family vacations, carpools, and other activities.

California was one of the first states to pass laws to promote "normalcy" for foster youth and remove unnecessary system barriers to experiencing typical childhood and adolescent activities. AB 899 (Liu 2001) established the Foster Youth Bill of Rights that enumerated twenty-one specific rights including the rights to contact family and friends inside and outside of the system and to participate in extracurricular, enrichment or social activities Two years later, AB 408 (Steinberg 2003) clarified the right of foster youth to participate in age and developmentally appropriate enrichment and social activities and established the prudent parent standard for foster parents in making the parenting decisions related to participation in those activities. SB 358 (Scott 2005) added "reasonable" to the prudent parent standard, defined, and extended the standard to parenting decisions related to the use of short-term babysitters. Subsequent bills expanded and clarified these provisions to encourage the development of approaches including the use of the reasonable and prudent parent standard in day-to-day parenting decisions to ensure young people, whether supervised by child welfare or probation, in foster care are able to live as "normal" a life as possible.

However, resource parents must keep in mind the specific rights guaranteed to foster youth and restrictions imposed by court orders in making reasonable and prudent parenting decisions. The standard cannot be used to circumvent specific rights of foster youth or orders of the court. For example, a resource parent can make a decision that a youth cannot use a cell phone during certain hours (e.g. at the dinner table or after bedtime) but may not decide that a foster youth cannot possess a cell phone.

Cal. Code Regs. tit. 22, § 89379 (foster youth have the right to make and receive confidential phone calls and possess their own belongings including a cell phone).
