

Rosca de Reyes





On January 6th, the Almklov Group Home celebrated Rosca de Reyes. The holiday has a Catholic foundation, and is also called "The Celebration of Epiphany", as well as, "Three Kings Day". Rosca de Reyes is a Mexican tradition that takes place 12 days after Christmas each year during social reunions with family, friends or colleagues in offices or homes. This tradition of eating together and sharing a Rosca de Reves bread with a hot chocolate to remember the Holy Kings, is made as a snack so that children are present and can participate in the tradition of getting together to enjoy and share a slice of Rosca de Reyes. It is important when you cut a slice that the figurine of the infant Jesus (plastic doll symbolizing Jesus newborn) is not showing. It is said that the person who finds the baby Jesus in their slice should host the party on Candlemas Day on February 2. On that day, the guests will expect to eat tamales and Mexican appetizers, so it is important to rejoin the same group that was present when the Rosca was cut. The person who finds the plastic wise man or Magi King in their slice must pay the costs of the party. In reality, the expenses of the party is shared. It is considered good luck and that you are fortunate if you find the baby Jesus and/or the Wise Man. The tradition of holding the reunion to celebrate the Day of the Epiphany comes from the middle ages in Europe, mainly from Spain and France. This tradition came to Mexico at the time of the early years of the viceroys.

The cooking at Almklov was shared by staff and spearheaded by Karina Garcia. She cooked chicken taquitos stuffed with cream cheese, cheddar cheese, chicken and potato. Nicole Juarez cooked her famous Chicken Enchiladas and additional crispy taquitos. Jill Howard cooked Pozole Verde, which is packed with fresh cilantro, jalapeño and tomatillo's. The boys of Almklov who had participated in the celebration before added their own family's tradition to the Almklov feast. One youth brought a radio into the kitchen and tuned it to a Mexican radio station, as he shared stories of helping his grandmother cook the meal while listening to Mexican music. Another youth helped hide the baby Jesus in the bread, as was the custom in his house and awarded to the youngest male. Our own little twist was that whomever received a slice of bread with the baby Jesus won a gift certificate to McDonald's. It was a surprise that there was a hidden baby Jesus for each of them!

All in all, the day filled the house with warmth, delicious cooking food, laughter and tradition. We all will look forward to next year!

KRYH

1. Clarifies that caregivers may access education records to ensure children in foster care receive the educational services they need to succeed in school.

2. Provides a technical statutory alignment with the Rules of Court, requiring Child Welfare case plans to include necessary educational contact information in the child's health and education summary.

3. Updates current education statutes related to education records access with Continuum of Care Reform efforts.

In other words, it is now easier for Resource Parents to access foster children's educational records that are often vital to the child's success. If you run into difficulties at a school site, SB 233 will help eliminate some of the barriers that have been previously encountered.

Safety Notes

In December we learned of a tragic event in which an innocent person, husband and father of several young children, was killed as a result of an intoxicated individual operating a vehicle. Whatever term is used, drunk driving, intoxicated driver, impaired driver, driving under the influence and etc., the results are the same. One should note that one may be impaired when taking prescription or "over the counter" medications. Bottom line, one should be alert and unimpaired when operating a nearly 1500 pound vehicle.

Although stiff penalties have been imposed on offenders, these measures have not kept people from driving after becoming intoxicated or impaired. For those who do not drive intoxicated or impaired, it serves us well to "watch for the other person". Please drive defensively. Avoid driving at night and in heavy traffic if at all possible. Create a safety zone around the vehicle when driving. This may not prevent someone from hitting you but may minimize the possibility of serious injury.
