Adventure Abounds at KBYH







One of many events that took place last month was an outing to Santa Barbara to play "Bubble Games". Our boys participated in all of the games which included Bubble Soccer, Zombie, Quittage, and Sumo Circle. Both staff and the kids had lots of fun running and knocking each other down. After the bubble games, the boys went to Shoreline Park and the beach. While at the beach, they explored the tide pools and walked the shores before calling it a day. The very next day, our boys traveled to Los Angeles to experience SKY Space LA. Sky Space LA is the tallest building in downtown Los Angeles. All of the boys were able to participant in an interactive sky slide. The boys were so amazed to see all of downtown Los Angeles. If you are a KBYH foster parent, the answer to the above question is yes, because we are working hard to make sure our agency is ready for new foster care regulations and standards that go into effect 1/1/17. RFA stands for "Resource Family Approval" and refers to new requirements that apply to all foster families in the state of California. Beginning 1/1/17, foster families will no longer be called foster families. What will they be called, you ask? Resource Families. All foster caregivers, whether they are a relative, with the county, or with an FFA like ours, will be called Resource Families. Look for upcoming information and trainings from KBYH that will be provided to ensure you are familiar with what these changes entail.

Foster Family of the Month: Jesus and Hortencia Salas



SAFETY

With Winter approaching we suggest that foster parents review safety procedures of their homes and service safety equipment. Please consider the following to help you examine home safety.

Smoke and Carbon Monoxide Detectors

- **Install smoke alarms and carbon monoxide detectors generously.** These should be on each floor of the house, covering all sleeping areas.
- **Test alarms monthly.** Replace any that don't work. (In any case, alarms should be replaced every 10 years.)
- **Replace batteries annually.** Or sooner, if the alarm chirps. Alarms with a battery life of 10 years are available.
- Clean all detectors. Vacuum each grille.
- **Post the fire department's carbon-monoxide-reporting emergency number.** If it differs from 911, keep the number by every phone.
- **Demonstrate the sound of each detector.** Family members need to know the difference.

Fire Extinguishers

- **Place extinguishers strategically.** Keep one in the kitchen and one on every floor. And learn how to use them.
- **Replace extinguishers when necessary.** Follow the schedule suggested by the manufacturer, and always replace an extinguisher that appears damaged. Please keep purchase receipts to verify the life of the fire extinguisher.
- Consider installing a sprinkler system.

Escape Plans

- Create an escape plan with two exit routes in case of fire. Practice it twice a year (once at night) with the whole family. For details, see the National Fire Protection Association's website, nfpa.org.
- Choose a meeting place. Set a plan for meeting up in case of a local or national disaster. See nfpa.org.

CPR and First Aid

- Ensure CPR and First Aid Certifications are current.
- You may consider having as many individuals as possible, including foster children, CPR and First Aid qualified.
