
<u>Summary</u>


Restraints Per 1000 day Beds




Average Length of Restraints



Escorts Per 1000 day Beds




Average Length of Escort



RESTRAINT SUMMARY: This benchmark indicates the number of restraints your STRTP had per 1000 day beds. A higher rate of restraints may indicate that your organization needs to re-evaluate the crisis intervention policies and staff training.

AVERAGE LENGTH OF RESTRAINTS: This benchmark indicates the average length of restraint of your STRTP. Higher restraint times may be indicative of possible safety issues present for the clients and the staff, as well as highlight the need for some revisions in policies related to screening. case planning and crisis intervention.

Run Away Per 1000 Day Beds





Self Harm Threats Per 1000 Days Beds




SELF HARM SUMMARY: Self-harm threats are those that resulted in an incident report sent to CCL.

Serious Injuries Per 1000 Day Beds




SERIOUS INJURIES SUMMARY: This section addresses client injuries reported to CCL that required medical attention beyond basic first aid.

MEDICATION ERRORS SUMMARY: These are medication errors which resulted in an incident report submitted to CCL with the exception of client refusal of medication (i.e., staff errors only)

CCL Type A Citations Per 1000 Day Beds




CCL TYPE A CITATIONS SUMMARY: These are citations issued by CCL for violations of Title 22 Regulations. Type A Citations are more serious violations, while Type B Citations are less serious.

CCL Type B Citations Per 1000 Day Beds




CCL TYPE B CITATIONS SUMMARY: These are citations issued by CCL for violations of Title 22 Regulations. Type B Citations are less serious.

Average Client Survey Scores (5.0=Max Score)



Substance Abuse Per 1000 Day beds




Actual Census/Licensed Capacity (%)




PERCENT CAPACITY SUMMARY: This benchmark indicates the average population percentage from your STRTP in the current reporting period.

Average Score Per Discharge Destination (Max Score=2.0)




AVERAGE SCORE PER DISCHARGE DESTINATION: Discharge destination is measured as follows: Most Desirable (2 Points; Family or Independent Living), Desirable (1 point; Foster Home, Lower Level STRTP, etc.), Neutral (0 Points; Same RCL), Less Desirable (-1 Point; Higher RCL or Emergency Shelter), Least Desirable (-2 Points; Incarceration, Psychiatric Hospital, etc.).



PERCENT OF PLANNED DISCHARGES SUMMARY: Planned Discharges are those in which the client exited the program through mutual agreement after treatment goals were met or partially met.

Percentage of Unplanned Discharges (Behavior Related)



UNPLANNED DISCHARGES BEHAVIOR RELATED SUMMARY: Unplanned discharges, Behavior Related occur when the client has not completed treatment due to running away, needing more intensive services, or incarceration.

Percentage of Unplanned Discharges (Not Behavior Related)



UNPLANNED DISCHARGES NOT BEHAVIOR RELATED SUMMARY: Unplanned discharges, Not Behavior Related occur when the client has not completed treatment due to reasons unrelated to his or her behavior, such as the placement was terminated by the parent, guardian, or client, funding source terminated, etc.
