DOG ADOPTION CONTRACT

I/We, the undersigned Adopter/s, understand and agree to the following terms of this contract in order to adopt the dog, further described within this document. The Adopter/s understand that non-compliance with the terms of this agreement gives the former owner the right to reclaim this dog without refund of the adoption fee or other compensation. The contract shall remain in effect for the life of the dog, or until the return of the dog to the owner. Terms and Conditions of the Adoption Contract: The full adoption fee will be collected at the signing of this contract. I agree to the adoption fee of \$1500, or \$1300 if the adopter has the dog sterilized on their own. There is a \$300 deposit. The balance paid in cash on pick up.

The Adopter/s agrees that if the dog is 4 years old or older the name cannot be changed or altered, from the same name that was given to the dog by the former owner. I agree that I will keep and care for this dog in a safe and humane manner, and as a family pet and companion. The adopter understands that the dog comes **"as is"**, Adopter agrees that the appropriate food, water, shelter and medical care for the duration of its life.

The Adopter agrees to abide by all state and local animal control and leash laws. I understand as the adopter, it is my responsibility to become familiar with these laws and to license the dog according to all regulations. The Adopter shall inform the former owner if they are no longer able to care for this dog and with sufficient time for the prior owner to exercise their retained Right of First Refusal and to reclaim the dog at no cost to the former owner. The Adopter agrees that the former owner will have the right to contact or visit the dog to check on the well-being upon request. The Adopter understands that the former owner makes no guarantees or warranties regarding the health or temperament of this dog. The Adopter agrees to be fully and solely responsible for this animal, and for any damages that may result from its actions.

The former owner, its heirs or representatives, shall not be held liable for the behavior of this dog or any damages it may cause. The Adopter entered into this contract of their own free will and understands that this is a binding contract enforceable by civil law. This agreement is enforceable once the adopt dog is turned over to the adopter.

To the best of my knowledge, this dog has no defects which make it unsuitable as a family pet and all information contained in this contract is true and correct. I certify that this dog has never bitten or injured any human or other pet. The former owner does not guarantee that the dog may eliminate in the adopter's home or any other location.
