WARNING

A person may not make any claim or recover from any person for any property damage or damages for personal injury or death resulting from the inherent risks of equine activities. Each participant and spectator in an equine activity expressly assumes the risk and legal responsibility for any property damage or damages arising from personal injury or death that results from the inherent risk of equine activities. Each participant has the sole responsibility for knowing the range of that person's ability to manage, care for and control a particular equine or perform a particular equine activity. It is the duty of each participant to act within the limits of the participants own ability, to maintain reasonable control of the particular equine at all times while participating in an equine activity, to heed all warnings and to refrain from acting in the manner that may cause or contribute to injury of an person or damage property.

I further agree to indemnify, hold harmless and defend the Pine State Pistoleros, Cowboy Mounted Shooting Association, other association sponsoring competitions, clinics, or events. The management of the competition/clinic/event, and their officers, directors, employees, members or agents and the owners and managers of the grounds where competitions, clinics, or events are held will be protected and held harmless from any and all claims for loss, damages, liability, injury, or death, however caused, resulting directly or indirectly from the rider's entry or participation in the competition/clinic/event or from acts or omissions of rider or rider's agents.
