Purchaser's License for Use TERMS AND CONDITIONS AGREEMENT

All of the materials, (prose, poetry, skits, monologues, plays and additional literary or artistic works), available on this website are the original works of Inspired Pen LLC, who holds the sole copyrights, and complete legal ownership of said materials. Inspired Pen LLC has elected to make such materials available for public use, at very nominal licensing fees, as it is our desire to be a conduit for meaningful theatrical content, which serves to spiritually enhance the viewing audience, through Christian-themed productions and presentations.

Throughout this license agreement the party(ties) purchasing the license for use will be referred to as the "Licensee" or "Purchaser." The owner of the material will be referred to as "Inspired Pen LLC," the "Author" or the "Owner," interchangeably.

Use of the material presented on this site will require the monetary purchase of a license, by the prospective Licensee, "prior to" receiving/downloading the PDF script.

<u>Downloading</u>, <u>printing</u>, <u>obtaining</u>, <u>duplicating</u> (in any form), <u>or distributing copies of material from this site</u> without remittance of the listed license fee is a copyright violation, and is strictly and legally prohibited.

(Exception: At the discretion of Inspired Pen LLC, some selected material may be offered without cost (free). Said "free" items will be clearly labelled as such by Inspired Pen LLC; but a user license must still be downloaded and retained by the Licensee for use. Inspired Pen LLC reserves to right to terminate any "free" licensing at any time, without prior notice).

<u>The prices for license purchases vary per item</u>, based on a number of factors, including but not limited to, the length of the work, time required to create the work, number of parts or characters involved, amount of detail and author/owner suggestions and/or notes included with the material.

The listed prices for license purchases do "not" reflect added mandatory sales/franchise taxes. (The Licensee should anticipate the addition of taxes to the product purchase). An additional fee "may" be incurred from the company(ies) handling money transfers for the electronic online purchases. ("If" incurred, said transfer fees are generally in the neighborhood of 3% of the purchase cost).

The purchase of a "License for Use" grants the Purchaser temporary permission, from Inspired Pen LLC, to present/perform the material in a public setting. Distribution of the script must be limited to the Cast and Technical persons directly involved in the presentation/production. Public distribution is prohibited.

The purchased license remains valid for a period of eight (8) months for a full-length play, and not to exceed four (6) months for prose, poetry, skits and monologues, from the date of purchase.

<u>Licenses are "not" transferable</u>, and may "not" be shared with, or distributed to, other parties (i.e. other groups outside the group which purchased the license).

Terms and Conditions Agreement (Continued)

Licenses are granted for "in-person" performances/presentations only.

<u>Performance of Inspired Pen LLC material is not to be made available through "live-streaming" on any social medial platform.</u>

<u>Video and audio recording of any kind, and/or playback across social media platforms are strictly prohibited</u>. (Exception: video clips, not to exceed 30 seconds, may be used for "advertisement only" for the scheduled production/presentation).

A Licensee's use of terms such as "I do not own the rights to this material" does "not" nullify the terms of this license. Public broadcast of Inspired Pen LLC's material, with this, or similar disclaimers, and without the purchase of a license for use, still constitutes "unauthorized use" of the material, and is a copyright infringement.

The "standard" license grants the Purchaser use of Inspired Pen LLC's material for "non-ticketed"/"non-pay" admittance events only.

The desire to use an Inspired Pen LLC work for a paid event or ticketed event will require non-standard additional licensing and fees. Please submit an email to the Administration detailing your desired use of the material, type of venue, anticipated viewership, per/person ticket cost, and estimated number of performances you desire to perform. The Administrator will review the purchaser's request, respond with any additional questions or instructions, and reply with a quote for the special licensing fee. If accepted by the Purchaser, a special contract will be made available via email. The signed contract and total special license fee must be received, prior to the performance date(s).

Inspired Pen LLC has been very deliberate and intentional with regard to creating quality, meaningful material for presentation. In order to retain the integrity of the piece, the message, its intent, quality and the cohesiveness of the work, editing and alteration of the purchased/leased material is prohibited without the expressed consent by the "Author" or "Inspired Pen LLC."

If written programs, advertisements (i.e. flyers, announcements, or the like), or social media ads (not to exceed 30 seconds), are used to broaden viewership for the performance of Inspired Pen LLC's material, appropriate acknowledgement of the owner of the material (i.e. <u>our Author's name</u>, or <u>Inspired Pen LLC</u>), along with the original title, is required in such advertisement.

Scripts can be reviewed, via the website, prior to purchasing, but may not be used without purchasing the license. If, after the license is purchased, the Licensee decides not to perform the work, or the performance is cancelled, the license fee will not be refundable.

Terms and Conditions Agreement (Continued)

If a catastrophic event occurs which delays the Licensee from presenting the work within the active timeframe of the purchased license, the Licensee may contact Inspired Pen LLC to request an extension of the license without incurring any additional costs.

Inspired Pen LLC reserves the right to waive the restricted posting of our materials to a social media platform, solely at our discretion, such as for special occasions and/or during special promotions. In such cases, a special contract will be required and the license fee (but not including the processing fee), will be refunded to only the specified Purchaser).

A copy of this License for Use with its Terms and Agreements is affixed to each work on Inspired Pen LLC's website. It is the responsibility of the Licensee to fully read, understand and comply with the terms contained herein. Purchase of the license constitutes acceptance of all terms.
