### Ultimate Marketing LLC Advocate Contractual Agreement

(International + Bonus-Eligible Version)

This Agreement (the "Agreement") is made between Ultimate Marketing LLC, located at 2000 E Lamar Blvd, Arlington, TX 76006, and the Advocate, whose name and address are submitted with acknowledgment.



### RECITALS

The Advocate is contracted to perform services for Ultimate Marketing LLC or remotely. The Advocate confirms compliance with any required local permits, tax reporting, and other legal obligations in their country or state.



### ADVOCATE REPRESENTATION

This is a 1099 independent contractor role. The Advocate is not an employee and is responsible for their own taxes, insurance, and benefits. This is not a partnership or joint venture.



### RESPONSIBILITIES INCLUDE:

Calling, texting, emailing, and voice drops (briefly explaining our offerings — no sales pitch required)

Serving as a key point of contact for potential clients  
Asking prospects if they are at a computer before walking them through the relevant page  
Welcoming them through the site and assisting with Zoom reservations



## COMPENSATION

### International Compensation Adjustment Clause

To maintain fair compensation across global regions, ambassador base pay shall be regionally adjusted according to the local cost of living and currency equivalence. The standard U.S.-based compensation of **\$500 per week** shall serve as a benchmark.

Adjusted compensation may be structured as follows:

- **Region 1 (High-cost countries):** United States, Canada, United Kingdom, Australia — \$500 + bonuses/week
- **Region 2 (Moderate-cost countries):** Mexico, Brazil, South Africa, Eastern Europe — \$250 + bonuses/week
- **Region 3 (Lower-cost countries):** Philippines, India, Nigeria, Pakistan — \$125 + bonuses/week

All payments are subject to verification of activity, compliance with terms, and minimum weekly output. Adjustments are made to ensure equity while respecting regional economic conditions.

No quotas expected but following instructions is a must.

Pay is issued via JW NeoBank (like PayPal or Cash App)

Pay cutoff: Wednesdays at 11:59 PM CT

Payday: Thursday after next



(one) - week probation period used to evaluate production. Pay is accrued during this time issued after completion. Successful probation may result in promotion and a pay increase. Reports are reported via Form 1099 (or international equivalent).

## EXPECTED CONTRIBUTION

This is not a sales role — but you are expected to maintain reasonable production consistent with worldwide Advocates. We do not expect perfection, but consistency, engagement, and professionalism are required.



## DASHBOARD REQUIREMENTS

Advocates must sign up and subscribe for Jeffrey's World updates to receive access to their dashboard. The dashboard monitors leads, analytics, and other important activity metrics.



BONUS STRUCTURE is during a two week incentive starting from the date of your agreement..



Referral Bonus: \$25

Per referred Advocate who completes probation



Conversion Bonus: \$25

For each customer who becomes a paying client



Content Bonus: \$25

For each approved live video (review, testimonial, etc.) uploaded to YouTube, TikTok, or Instagram

#### AMBASSADOR PATHWAY

That's because Advocates are not paid like Ambassadors.

Ambassadors earn more — including team overrides, leadership bonuses, and commissions — but access is limited.

Scripts, tools (like CRM), and templates may be provided as guidance only — you are not required to follow them exactly. You maintain control of how you perform the work.



#### MODIFICATIONS

We may update this Agreement to protect you and the company. A 7-day notice will be given. Changes will not apply retroactively.



#### TERMINATION

This Agreement may be ended immediately for cause (fraud, policy breach, misconduct)  
Or by either party with 10 days' written notice  
In the case of verified harm to the company, pay may be withheld for the current period
