- Submit your banking info for direct deposit (we'll soon be switching to our JW NeoBank platform, similar to PayPal or Cash App).

Between: Ultimate Marketing and the Ambassador Lead Generator (a.k.a. Associate) whose name and address will be submitted via email or Zoom response.

#### **Recitals**

**This agreement outlines the expectations, responsibilities, and mutual benefits of your engagement as an independent associate of Ultimate Marketing.**

**Associate Representation** You affirm that you are entering this agreement of your own free will, and that the information you provide is accurate.

#### **Responsibilities and Duties**

- You are expected to follow our ambassador engagement and maintain professionalism.
- You must maintain at least 3 active full-time ambassadors on your team to qualify for the Team Leader overrides.
- You will follow instructions as your team is expected to do the same.
- A marketing system will be provided, generating leads, assuming a minimum of 20 hours weekly engagement.
- These leads are abundant and meant to serve Ultimate Marketing first — you may discuss broader use with your instructor, as we believe in an abundant mindset and opportunity for all.

#### **Ambassador Follow-Up Clause**

As an Ambassador, one of your primary responsibilities is to follow up with leads that Lana (our AI strategist) has engaged. You will:

- Monitor leads who have interacted with Lana and been directed to reserve a Zoom meeting
- Follow up to confirm whether they've scheduled their meeting — or need assistance rescheduling
- Remind leads of their upcoming appointment and the value of attending live
- Answer basic questions using the resources already provided (FAQs, agreement, video)
- Notify our team if a lead remains unresponsive after multiple attempts

Lana opens the door. You help them walk through it.

This ensures that no qualified prospect slips through — and increases your close rate, commissions, and confidence as a high-performing Ambassador.

## **RESPONSIBILITIES INCLUDE:**

Calling, texting, emailing, and voice drops (briefly explaining our offerings — no sales pitch required)

Visiting JeffreysWorld.com at least once daily (twice preferred) for updates  
Asking prospects if they are at a computer before walking them through the relevant page Welcoming them through the site and assisting with Zoom reservations

## **Ambassador Path & Compensation**

Ambassadors do not receive a salary or weekly draw. This path is designed for those who think entrepreneurially and value independence — individuals who want to position themselves for growth and build income through performance and results.

- **Principal Ambassador Path** by purchasing the \$6,250 Done-for-You AI Automation Blueprint. *Designed for leaders ready to scale immediately — with everything managed for you plus 100M+ impressions to position your brand at the highest level.*

### **First Sale Double Bonus Boost:**

- Subscribe a \$380 package → Earn \$760 advance bonus

- Compensation Terms**

All qualifying Ambassadors shall be paid weekly on Thursdays, with a one- week pay hold to allow for standard bookkeeping and processing.

- Override Commissions**

Tier# Active Ambassadors      Override Tier 1recruit 3 ambassadors • 5% override Tier 2recruit 6 ambassadors • 7.5% override

Tier 3recruit 10 ambassadors • 10% override

Tier 4recruit 100 ambassadors • 15% override

Tier 5recruit 1000 ambassadors • 20% override

- Falling below the tier active team members will result in a reduction or pause in override eligibility until the qualification is met again.

### **Qualification for overrides:**

- Ambassadors must be proactive with their team - enroll a minimum of three (3) personally sponsored active ambassadors to qualify for overrides.
- Upon reaching this qualification, the overrides become retroactive to any of the unqualified periods. If an Ambassador fails to meet this requirement or stops participating before meeting it, they do not qualify for override payments, retroactive or otherwise.
- Example for overrides; Earn **10% overrides** on your team Ambassador's bonuses Their \$5,000 = Your \$500 Their \$50,000 = Your \$5,000

## DASHBOARD REQUIREMENTS

- If you have a negative commission balance at termination, repayment is not required.
- However, if you terminate, we recommend keeping your account open — future commissions will still accrue.
- You may designate a beneficiary for your commission balance in the event of incapacity or death.

## INTERNATIONAL COMPLIANCE

This Agreement is governed by U.S. law. International Advocates must comply with their own tax and business obligations. By agreeing, you confirm this compliance.

## SAFE HARBOR CLAUSE

Scripts, tools (like Hero CRM), and templates may be provided as guidance only — you are not required to follow them exactly. You maintain control of how you perform the work.

## **MODIFICATIONS**

We may update this Agreement to protect you and the company. A 7-day notice will be given. Changes will not apply retroactively.

## **TERMINATION**

This Agreement may be ended immediately for cause (fraud, policy breach, misconduct)

Or by either party with 10 days' written notice

In the case of verified harm to the company, pay may be withheld for the current period

## **Execution to officially activate this agreement:**

Reply during Zoom meeting with the words "I agree", your full name, and your current address along with your direct deposit preference and information for your compensation.

You acknowledge and agree to the terms outlined above through this Zoom meeting which serves as your acknowledgment - equivalent to your signature.

**Date is the timestamp on the replied Zoom meeting.**

**If you don't subscribe on your first Zoom meeting, reschedule to subscribe.**
