




ICWA Case Resolutions by Year

*Percentage of total case outcomes




Comparison to 2021

Outcomes Compared to General Population






The Tribe adopted by way of its Membership Ordinance the authority for the Enrollment Department to expedite enrollment verifications and processing of enrollment applications for ICWA and child dependency matters.


- ❖The department has two full-time dedicated employees funded by BIA Tiwahe supporting ICWA/CPS matters.

Pascua Yaqui Tribe Membership – Legislative History

- **1963 Pascua Yaqui Association** Eligibility: One-quarter (1/4) Yaqui blood, ceremonially associated and living among the Yaqui people/community at the time of application.
- 1978 Pascua Yaqui Tribe Federally Recognized Established the Original Base Roll, one-quarter (1/4) and U. S. Citizen.
- 1989 Approval Tribe's Constitution

Eligibility: Direct lineal descendants of original base roll members who possess one-quarter (¼) Yaqui BQ and are U.S. Citizens. Corrections to the original base roll were made with BIA approval provided that new persons not be added to the roll.

1994 Open Enrollment Act (Public Law 103-357)

Eligibility: Possess one-quarter (1/4) Yaqui BQ, U.S. Citizens and applied for membership by October 14, 1997.

2015 PYT Constitution Amended

Eligibility: Direct lineal descendants or <u>collateral persons NEW</u> (Yaqui blood relatives with ties to PYT) who possess one-quarter (¼) Yaqui BQ and are U.S. Citizens. Removed BIA from the tribe's enrollment processes that included their approval of Yaqui BQ modifications.

2005 PYT Blood Quantum Modification Procedures approved by the Pascua Yaqui Tribal Council

To date, the department has formally made 1000+ Yaqui blood quantum modifications (corrections) to the original and current tribal roll.

Enrollment Verification Process

PYT is the authoritative source on whether a child is a tribal member, eligible or ineligible for membership.

- ❖ Enrollment verification is accomplished by utilizing various available resources; ProQuest/ancestry.com, PYT enrollment, genealogy and state vital records databases.
- ❖Yaqui blood quantum verification also involves identifying and initiating if warranted corrections (increase) in Yaqui blood quantum.
- ❖ DNA for purposes of enrollment and confirmation of blood relatives is acceptable evidence to confirm paternity and kinship Yaqui blood relationships.
- ❖ Providing the necessary enrollment status and kinship reports to identify possible relative placement.

Enrollment Verification Process

Timely verifications to determine the enrollment category and status of the child.

- **Non-member** verification is based on NO ties to the tribe based on the information presented to the Enrollment Department. Important to document and track for reference.
- **Eligible** verification based on the information presented to the Enrollment Department that the child is eligible considered preliminary.
- **Enrolled** verification does not necessarily have to be a CDIB, but a simple enrollment verification form as to not disclose blood quantum.
- **Kinship Reporting** Perform extensive genealogy research providing to Social Services kinship reports to assist in identifying relative placement.

Enrollment Department Role Supporting ICWA

Developed inter-departmental procedures with PYT Social Services and the Office of the Attorney General to support:

- Work closely with Social Workers to identify which children are eligible for enrollment but not yet enrolled and initiate the enrollment application process.
 - Enrollment will complete the application utilizing birth documents with confirmation of biological parents and information from the official membership records.
 - Assigned authorized Social Worker or Aid on behalf of the PYT will sign the enrollment application as the legal guardian of the child who is a ward of the court.
 - Expedite the processing of the enrollment application and provide update enrollment status to Social Services and the Office of the Attorney General.
- Provide updated enrollment status to Social Services and Office of the Attorney General.
- Records Management Helpful to flag your system and physical file to prevent from the unauthorized disclosure. Seal adoption records and creating a decoy file.
- Provide guidance to placement family on how to go about applying for tribal services New Enrollee Packet.
