I understand that all Homeowners at Alpine Lake are required to pay charges for water and sewer service for the Home, and I understand that a minimum monthly charge is assessed to each home regardless of use of water and sewer services. By completing this application, I agree to pay all water and sewer service fees during the time I am the owner of a home at Alpine Lake.

As a Homeowner, I agree to pay the charges for water and sewer services on time and in accordance with rates as approved from time to time by the Public Service Commission of West Virginia or its successor(s) in interest having jurisdiction over the premises. I understand that I am given a copy of the tariff for these services at the time of this Application. However, I understand that I have agreed, by reason of the Declaration of Restrictions covering my property at Alpine Lake, so long as I am a homeowner and subject to that Declaration, that I must pay the minimum monthly fee even if services are discontinued.

I understand that Alpine Lake Public Utilities Company may accept payment for water and sewer services provided to my home from another person or entity, such as a renter of the home. I agree that I remain responsible for all water and sewer service charges not paid by the renter or other person for any reason. I also agree that I remain fully responsible for payment of these charges until I have both (a) ceased to be an owner of the home at Alpine Lake and (b) provided written notice to Alpine Lake Public Utilities Company that I am no longer the homeowner and therefore no longer subject to my obligations under the Declaration of Restrictions.

Pursuant to Public Service Commission (“Commission”) rules, any utility may decline to serve an applicant until he has complied with these rules and the utility's rules set forth in a Commission approved tariff governing water and sewer service. The utility may refuse to serve an applicant if the applicant's installation of sewer piping is hazardous or of such character that satisfactory service cannot be provided. In the event that the utility shall refuse to serve an applicant under the provisions of this rule, or any other rule incorporated herein, the utility shall inform the applicant of the basis of its refusal. In the case of a dispute, you may apply to the Commission for relief.
