

CONSENT AND RELEASE

For good and sufficient consideration, receipt of which is hereby acknowledged, I, the undersigned, grant to The Boykin Spaniel Club & Breeders of America, Inc. I agree that the Product need not be submitted to me for approval and that BSCBAA, its licensees, agents, assignees and others working for it or on its behalf shall be without liability to me for any distortion or illusionary effect resulting from the creation or publication of the Product. I hereby waive any rights and any and all claims arising under the Visual Artists Rights Act, 17 U.S.C. 106A, and any comparable state or local law, as amended from time to time, with respect to the Images. I further agree that I shall have no claim to any compensation.

I represent and warrant that I am the sole and exclusive owner of all rights, including copyright, in and to the Images and of the unrestricted right to grant the use of the Images; that the use of the Images does not infringe upon the rights including, but not limited to, intellectual property rights, right of privacy or publicity, trademark, and does not infringe the rights of any third party; and that I have full right and authority to grant the rights granted herein. I further represent and warrant that I am 21 years of age or older.

I agree to be solely responsible for any legal liability arising out of or relating to the Images. I hereby agree to release, indemnify, defend and hold harmless BSCBAA, its licensees, agents, assignees and others working for it or on its behalf from any and all liability that may occur in connection with the use of the Images by BSCBAA, its licensees, agents, assignees and others working for it or on its behalf and arising out of or relating to the breach or alleged breach of the foregoing representations and warranties.
