



# San Gabriel Valley Jr. All-American Football and Cheer Conference

## Minor/Child - Release of Liability and Waiver



In Consideration of \_\_\_\_\_, my child, being allowed to participate in the football or cheer programs of the \_\_\_\_\_ Franchise, which is a legally distinct organization/entity, not operated or controlled by San Gabriel Jr. All-American Football and Cheer, despite its membership with San Gabriel Valley Jr. All-American Football and Cheer Inc., the undersigned acknowledges and agrees that:

The risks of injury and illness (ex: including but not limited to communicable diseases such as influenza, MRSA, and COVID-19) to my child from the activities involved in these programs are significant, which can include the potential for permanent disability or death, and although particular rules, personal discipline, and equipment reduce these risks, the risk of serious injury and illness do exist; and,

1. On behalf of MYSELF, SPOUSE, AND CHILD, I freely and knowingly assume all such risks, whether known or unknown, including if these arise from the negligence of the releases or others, and assume full responsibility for my child’s participation; and,
2. I willingly agree to comply with the program’s published terms and conditions for participation. If I observe or become aware of any unusual or significant concerns related to my child’s willingness and physical well-being that would affect his participation, the participation of others, or the program itself, I will remove my child from participation and immediately notify the team official and franchise official; and
3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS San Gabriel Valley Jr. All-American Football and Cheer Inc, including the Franchise stated above; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring partners, advertisers, and if applicable, owners and lessors of any premises used to conduct the event (“Releasees”), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my child’s involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY IMDEMNIFY AND HOLD HARMLESS all of the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
5. I, the parent/legal guardian, assert that I have explained this to my child; the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child understands this agreement.
