**72 Hour Cancellation Policy:**

All Tee Times Must be cancelled or modified 72 hours before the tournament/group scheduled date, otherwise a Refund will not be issued. Modifications to Group/Tournament tee times can be made up to 24 hours before tee time. If Cancellations or No-Shows occur inside of 24 hours, the credit card on file will be charged.
