SAILING INSTRUCTIONS

The Organising Authority (OA) is Fairlie Yacht Club (FYC).

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 RULES

- 1.1 The Event will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- 1.2 The prescriptions of the RYA available at <u>www.rya.org.uk/racing/rules</u> will apply.
- 1.3 The World Sailing Offshore Special Regulations (OSR) available at <u>www.sailing.org</u> will apply.
- 1.4 The IRC rules available at <u>www.ircrating.org</u> will apply (except for Part D that will NOT apply).
- 1.5 The CYCA Handicap System available at <u>www.cyca-online.org.uk</u> will apply.
- 1.6 The Multihull Offshore Cruising & Racing Association (MOCRA) Rating Rules available at <u>https://mocra-sailing.org.uk/racing/</u> will apply.
- 1.7 The Event is open only to boats crewed by two adults aged 18 years or older

2 SAILING INSTRUCTIONS

Any change to the sailing instructions will be posted not less than one hour before the first start of the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.

3 COMMUNICATIONS WITH COMPETITORS

- 3.1 The online official noticeboard is located at: <u>www.largsregattafestival.com.</u> There will be no physical notice board.
- 3.2 [NP] The race committee may make courtesy broadcasts to competitors on VHF Channel 77.
- 3.3 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 CODE OF CONDUCT

- 4.1 [DP] Competitors and support persons shall comply with reasonable requests from race officials.
- 4.2 [DP] Competitors and support persons shall place advertising provided by the OA with care, seamanship, in accordance with any instructions for its use and without interfering with its functionality.

5 SIGNALS MADE ASHORE

Signals ashore will be made from the flagpole located at Largs Sailing Club and at Fairlie Quay Pier.

6 SCHEDULE OF RACES

- 6.1 Dates of Racing: Saturday 2nd September to Sunday 3rd September 2023
- 6.2 Number of Races: There will be one race for each class.
- 6.3 To alert boats that a race or sequence of races will begin soon, an orange flag will be displayed (with one sound) not less than 5 minutes before the first warning signal of a series of starts is displayed.

The orange inflatable mark should be passed to starboard and Fairlie Quay Pieto port. Additional marks on or near the start line shall be ignored. 3	If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee will attempt to hail her sail number. Failure to hail her number, failure of her to hear such a hail, or the ord in which boats are hailed will not be grounds for a redress for request. This changes RRS 62.1(a).

5	The normal starting sequence shall not be interrupted by a general recall. The warning signal for the class which had a general recall shall be five minutes before its starting signal and shall normally be displayed at the starting signal of the last class to start correctly in the schedule. If more than one class is subject to a general recall, the second of					

12.5 of the last class to start correctly in the schedule. If more than one class is subject to a general recall, the second of these classes shall start five minutes after the first and so on. If a class subject to general recall is the last or only class to start, the next signal shall be the new warning signal, which shall normally be displayed five minutes after the original starting time.

13 CHANGE OF THE NEXT LEG OF THE COURSE - not applicable at this event

14 THE FINISH.

- 14.1 The Finish Line shall be between an orange inflatable mark, approximately at 55.46.59N. 004.52.17W and Largs Sailing Club flagpole. The orange inflatable mark shall pe passed to PORT. The finishing line shall be crossed from south to north. Additional marks on or near the finish line should be ignored including the midchannel mark for Largs Yacht Haven and Fairlie Yacht Club starting grid. Competitors should be aware of shallow water to the north of the finishing line. During the hours of darkness, the finish orange inflatable buoy approximately at 55.46.59N. 004.52.17W shall be lit by a solid orange light.
- 14.2 [DP] Boats shall not re-cross the finish line after finishing.
- 14.3 [DP] All competing yachts shall identify themselves by calling the Race Committee on VHF Ch 77 approximately 5 minutes from the finish line. In addition, yachts finishing during the hours of darkness shall illuminate their sail number to assist identification. After finishing and once clear of the finishing area and in safe water, competing yachts shall report to the Race Committee on VHF Ch 77 to ensure correct identification and recording of their finishing time. In addition, boats should take their own finishing time, and where possible, the identity of boats immediately ahead and astern.
- 14.4 [DP] Any boat that retires from the race shall notify the Race Committee on VHF Ch 77, or by telephoning the Race Officer on 07711 849646.

THE RACE COMMITTEE MUST BE INFORMED IF A BOAT RETIRES AND AN ACKNOWLEDGEMENT SHOULD BE RECEIVED. THIS IS AN IMPORTANT SAFETY MATTER.

15 PENALTY SYSTEM – no additional penalties are applicable at this event.

16.1 Boats that do not finish within the time limit shall be scored TLE. This changes RRS 35, A4 and A5.

17 HEARING REQUESTS

- 17.1 The Exoneration Penalty [and the Advisory Hearing and RYA Arbitration of the RYA Rules Disputes Procedures may be available.
- 17.2 Competitors should inform the Race Committee of any protest they wish to lodge within 30 minutes of finishing.
- 17.3 Protest forms are available from: <u>https://www.rya.org.uk/racing/running-racing/templates</u> or from <u>www.fairlieyachtclub.org.uk</u>
- 17.4 Protests should be delivered to a Race Committee Member (07711 849646 for location), LYH reception 0900 -1700, or emailed to secretary@fairlieyachtclub.org.uk within the time limit.
- 17.5 The protest time limit is 60 minutes after the last boat has finished or the race time limit. The protest time limit shall be posted on <u>www.largsregattafestival.com</u> at the conclusion of racing.
- 17.6 Notices shall be posted on <u>www.largsregattafestival.com</u> within 30 minutes of the expiry of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. The venue for protest hearings shall be included in the notice. Parties to each protest are requested to remain in Largs Yacht Haven.
- 17.7 Notices of protests by the race committee shall be posted to inform boats under RRS 61.1(b).
- 17.8 Protests shall be heard as soon as possible, in approximately the order of receipt. It is the responsibility of the Protestor, Protestee and Witnesses to make themselves available for the hearing.
- 17.9 A request for reopening a hearing shall be delivered no later than 15 minutes after the party requesting reopening wasinformed of the decision. This changes RRS Rule 66.
- 17.10 The Protest Committee may impose a penalty that is less than DSQ for boats that have been found to break RRS 55. [DP]

19 SAFETY REGULATIONS

19.1 Clydeport Operations Limited Restrictions

NARROW CHANNELS. Attention is drawn to the International Regulations for the prevention of collisions at sea, 1972. Particular notice shall be taken of Rule 9b, which states that "a vessel of less than 20m in length or a sailing vessel shall not impede the passage of a vessel which can safely navigate only within a narrow channel or fairway". Whilst racing or ona passage in the Firth of Clyde north of Cumbrae Head yachts shall regard any such recommended channels as a "NarrowChannel" within the meaning of the IRPCS 9b.

Furthermore, Clydeport Operations Limited has decreed that any waters in the Firth of Clyde where vessels by virtue of their size, draught, speed or proximity to land, hazards and other vessels are unable to manoeuvre freely shall be regarded as a "Narrow Channel". Whilst racing, any yacht which is unable for reasons of lack of wind or other

cause, to sail clear of a large power-driven vessel shall start her engine and/or paddle in order to clear and thereafter shall report full details to the Race Committee.

Competitors are reminded of the Clydeport Operations Limited by-law which prohibits yachts and other craft from manoeuvring within 100m of any ferry terminal. Particular regard should be paid to this when in the vicinity of the CalMac facilities at Largs and Cumbrae.

19.2 Sailing During The Hours Of Darkness

Between the hours of sunset and sunrise, the rules contained in RRS Part 2 shall cease to govern the race, which shall be continued under the International Regulations for Preventing Collisions at Sea. Navigation lights shall be shown during the hours of darkness.

19.3 Boats shall comply with the World Sailing OSR as follows:

Class 1 & MOCRA Multihull

Category 3 is intended for races over open water, most of which is relatively protected or close to shorelines.

At least one spare lifejacket shall be carried for each crew member.

Where an inflatable dinghy is used in place of a life raft a suitable pump shall be carried to enable the inflation of such a dinghy.

Classes 2, 3, 4, 5, & 6 It is recommended that these Classes comply with Category 4

Category 3

The Race Committee of Fairlie Yacht Club reserves the right to re-allocate competing yachts to a Class other than that entered if deemed appropriate. Notice will be given of any changes.

Yachts so effected will be permitted to withdraw their entry if desired, with refund of entry fee.

20 REPLACEMENT OF CREW OR EQUIPMENT

Substitution of the registered person in charge during the race is not permitted without prior written approval of the Race Committee.

21 EQUIPMENT AND MEASUREMENT CHECKS

[DP] A boat or equipment may be inspected at any time for compliance with the appropriate rules and sailing instructions. On the water, a boat can be instructed by a race committee measurer to proceed immediately to a designated area for inspection.

Yachts entered in Class 1 may be inspected by Safety Equipment Advisors on behalf of the Organisers.

30 RISK STATEMENT

30.1 Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

- 30.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that.
 - (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
 - (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat orashore.
 - (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions.
 - (d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
 - (e) The provision of a race management team, committee boats and other officials and volunteers by the event organiserdoes not relieve them of their own responsibilities.
 - (f) The provision of any patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as canbe practically provided in the circumstances.
 - (g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.


31 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per event or the equivalent.











The Long Course – Round the Isle of Arran – Applies to Class 1 Only









Course A - Ascog Patches Applies to Class 7 and as an Alternative Course for All Classes
