Member Rights

We ran some scenarios concerning when a member might need union representation...

FYI - when someone is acting in their official capacity as a union representative and they are asked to attend a meeting with a member at a time that interferes with their teaching duties, they can tell the principal they need to be in the classroom, but can represent the member at another time. "I know you feel this is an emergency right now, I need to represent my member, but I cannot at this time as I need to be in the classroom- when can we meet so I can be there?"

A member who feels they need union representation in a meeting with administration, should let admin know that they want Union representation, and then contact their building rep to find a common time to meet. The building rep can then reach out to Marty, Nick, or Lisa for assistance if needed.

In good standing. Received a \$40,000 grant from Education Minnesota. Rent is going up minimally.

The school board removed the preschool teachers from the bargaining unit atthe end of last school year. They now have an independent contract. They are looking to form new bargaining unit connected to us. This process will go forward soon. There was a delay in the process because the school board and Dr. Jacobus objected to the use of the word "Teacher" for these teachers. Union disagreed and the Bureau of Mediation ruled in our favor a couple of weeks ago. Now waiting for a date for a vote to see if they want to be a union. Around 27 teachers involved.

 - endorsement process screening team will give a recommendation to the Exec Board. Exec board will vote and then if there are any endorsed candidates they will be notified. UTSWC will work with Ed Mn and the Labor Federation to send postcards, etc.
 - 3. Early voting has started already. Election day on November 5: Will be contacting all EdMN members in the district to vote, members of other unions. We have the day off- feel free to help get people to the polls! There are decisions that need to be made that the school board is not making, we need new board members. October meeting (tentatively) will be a time when we can invite endorsed candidates to come and visit.
