Bomb City Business Founders Club

Purpose:

To define the benefits, recognition, limitations, and program guidelines associated with participation in the Bomb City Business Founders Club.

1. Program Overview

The Bomb City Business Founders Club was created for local businesses that choose to become part of Bomb City's story before opening day.

Business Founder participation is a **one-time, pre-opening opportunity** designed to recognize businesses that believed in Bomb City's vision during its original buildout.

Business Founder participation is **not**:

- An investment
- Equity ownership
- A sponsorship agreement
- A partnership interest in Bomb City Bike Park
- A membership subscription
- Advertising rights

Instead, Business Founder participation provides permanent recognition and exclusive Founder benefits based on the selected Founder level.

2. Business Founder Status

Business Founder recognition is intended to permanently recognize businesses that supported Bomb City during its original development.

Recognition may include:

- Founder Wall recognition
- Website recognition
- Unique Business Founder Number
- Business Founder Badge
- Opening recognition
- Preview event invitations
- Business Founder communications
- Community recognition
- Other Founder benefits associated with the selected level



Business Founder status does **not** provide:

- Ownership
- Voting rights
- Revenue sharing
- Profit participation
- Management authority
- Exclusive sponsorship rights
- Naming rights
- Advertising exclusivity

3. Business Founders Club Is Not an Investment

Participation in the Business Founders Club does not constitute:

- Equity
- SAFE participation
- Securities
- Debt financing
- Loans
- Profit sharing
- Revenue participation
- Partnership ownership

Business Founders are recognized as early supporters of Bomb City—not investors unless a separate written investment agreement exists.

4. Business Founder Recognition

Business Founder recognition is intended to become a permanent part of Bomb City's history.

Recognition may include:

- Founders Wall
- Website recognition
- Launch recognition
- Digital recognition
- Community recognition
- Future Founder displays
- Other reasonable recognition formats selected by Bomb City

Bomb City reserves the right to determine the final design, location, size, materials, and presentation of all recognition elements.

5. Founder Levels

Business Founder benefits are based upon the level selected at the time of purchase.

Current Founder Levels include:

6. Business Founder Numbers

Every Business Founder will receive a unique sequential Founder Number identifying their place among Bomb City's Original Business Founders.

Examples:

ABC Plumbing • Business Founder #003

Smith Engineering • Business Founder #017

Founder Numbers are permanently assigned and cannot be reassigned once issued.

7. Website Recognition

Business Founders will receive recognition on Bomb City's official website based on their Founder level.

Recognition format, placement, and presentation are determined by Bomb City and may evolve as the website grows.

8. Bomb City Community Partner Package

The Visionary Founder level includes the first year of Bomb City's Community Partner Package upon park opening.

This benefit:

- Begins upon opening
- Is valued at the standard annual Community Partner rate



May be renewed annually at the then-current Community Partner rate
Does not transfer ownership or exclusive sponsorship rights
Community Partner benefits are governed by the Community Partner Program in effect at the time of activation.

9. Transferability

Business Founder status is generally non-transferable.

Ownership changes, business sales, mergers, or name changes may require Bomb City's approval before Founder recognition is modified.

10. Refunds

Business Founder purchases are intended to support Bomb City's original buildout and are generally non-refundable except where required by law.

11. Program Availability

The Business Founders Club is a **limited-time pre-opening program**.

Once Bomb City opens, this program will permanently close.

Future businesses may participate through annual Community Partner opportunities, but they will not receive Original Business Founder recognition.

12. Right to Modify Program Details

Bomb City reserves the right to clarify, update, or modify program details as necessary while preserving the overall intent of the Business Founders Club.

13. Acknowledgment

By participating in the Bomb City Business Founders Club, the Business Founder acknowledges that:

- Participation is not an investment.
- Benefits are limited to the purchased Founder level.
- Founder recognition is permanent, subject to reasonable maintenance and operational changes.
- Bomb City is a phased development project.
- Program details may evolve as the project progresses.
- The Community Partner Package is governed by its own separate program and terms.
