Script for Setting a Field Training Appointment

Is that true? So with that being said, can you mark that on your calendar and can we consider this a confirmed & definite appointment? Thank you will send you a reminder as well as the Zoom link for his/her training appointment. We'll see you then!

It's time-sensitive and I need to get it scheduled this week so I can take my test. Will you help me?

You're the best. Thank you! I'm training on Tuesday and Thursday. Which day can you do?

Great! 6 p.m. or 8 p.m.?
[Wait for answer]
Perfect. Confirmed! I'll send you the Zoom link. Thanks again.
