The Hesperia Wranglers Queens Contest is held annually to select five young ladies who have the desire and enthusiasm to serve as Goodwill Ambassadors for the Western lifestyle and The Hesperia Wranglers.

The Hesperia Wranglers has pledged to make the program memorable for each contestant. The committee is confident the Hesperia Wranglers 2022 Queens chosen will represent this community in a grand manner.

**WHO ARE THE HESPERIA WRANGLERS 2022 QUEENS?**

The Hesperia Wranglers 2022 Queens symbolize the youth of our community and those who wish to promote the great western way of life. They are an ideal western type of All-American girl who has horsemanship skills and knowledge, an appealing appearance, a congenial personality and knowledge of the equine industry, the High Desert, and the history of the Hesperia Wranglers. They are young ladies who enjoy travel and have a sincere interest in garnering educational experiences that will assist in laying a solid foundation for their future.

**WHAT TYPE OF YOUNG LADY DOES THE CONTEST ATTRACT?**

- ❖ A young lady who wishes to be a representative of her community, the western way of life and the Hesperia Wranglers. **The image of Miss Hesperia Wranglers is one of a wholesome, All-American, single cowgirl.**
- ❖ A young lady who loves horses and everything they represent. A young lady who portrays unmatched horsemanship, sportsmanship, high moral, and ethical character.
- ❖ An ambitious young lady who is interested in furthering her chosen career through higher education and special training.
- ❖ A young lady who can speak intelligently and display dignity in all situations.

**ELIGIBILITY**

1. There are five age divisions:
  - A.) Tiny Miss – 3 thru 5 (lead line)
  - B.) Petite Miss –6 thru 9 years of age
  - C.) Young Miss-10 thru 13 years of age
  - D.) Junior Miss -14 thru 16 years of age
  - E.) Miss - 17 thru 26 years of age

Birth certificate must be provided upon request. **If you currently hold a title, you must be able to plan accordingly for appearances and it must be approved by the queen committee.**

- ◆ **Each contestant must be a member of the Hesperia Wranglers prior to the pageant commencing and throughout their reign should they become a titleholder. If they do not renew their membership, it is grounds for immediate dismissal. They must also reside within a 100-mile radius of Hesperia.**
2. Each contestant shall pay a **non-refundable entry fee.** **Applications and entry fee monies are due on or before, but no later than August 1, 2021.** Mail to **Hesperia Wranglers, Inc. PO BOX 400222, Hesperia, CA 92340.** All checks must be made payable to **Hesperia Wranglers** and are **due no later than August 1, 2021.**

3. Each contestant, will be required to raise **\$400.00 worth of sponsorship** (Tiny contestants will be required to raise \$250.00) through any of the following: program advertisements, sponsorships of buckles or crowns, sponsor arena banners or raffle tickets by **September 11, 2021 no later than 6:00 p.m.** Fundraising monies must be turned in, in order to compete. Money/ tickets will be accepted by the Coordinator, Queen Committee or a member of the Hesperia Wranglers Board of Directors.
4. **Contestants must be a natural born female, single and never have been married.**  
A.) Miss Hesperia Wranglers shall not allow herself to be photographed in any manner during her year that would imply that she is in a dating relationship. She may have a boyfriend but will not enter into a public dating relationship during her reign. There will be no public announcements of engagement, no taking or posting of photographs with the titleholder's significant other, and no public display of affection with the titleholder's significant other. Miss Hesperia Wranglers is a young lady that is single and wholesome and consequently, any behavior that portrays Miss Hesperia Wranglers in a manner inconsistent with the spirit of this rule, will subject the titleholder to disciplinary action, up to and including termination of her reign.
5. **Contestants may not have nor had any children.**
6. **If you have any pierced body part, other than the standard 2-4 earring piercing (navel, nose, eyebrow, etc.) you will agree to remove earrings etc. (or in the case of a navel, conceal) whenever appearing as a Hesperia Wranglers titleholder. Keep in mind that spacers/gauges/plugs are not allowed. This also applies to concealing any tattoos. A Hesperia Wranglers titleholder or contestant will not be allowed to make any appearances if she has a "hickey". This is inappropriate in setting a good example for the community. The determination will be made by the Queen Coordinator and Committee. Again, if the Hesperia Wrangler's titleholder cannot make a scheduled appearance due to her body being thus marked, a runner up will substitute in her place. Continued infractions of this will be grounds for dismissal (this is applicable for any and all the above markings).**
7. All contestants, their family and supporters agree to follow the code of conduct and all rules whether written or oral. Violation of the code of conduct or rules may result in dismissal from facilities or contest.
8. The Hesperia Wranglers shall have the sole right to publish or cause the publication in any media, and use in any reasonable manner, the name, basic biographical background, and photograph of each contestant for the purpose of the promotion of the Hesperia Wranglers 2022 Hesperia Wranglers Queens Contest.
9. Hesperia Wranglers expressly reserves the sole right to accept or reject any application, as it may in its sole discretion deem appropriate.
10. **All contestants must always be able to follow directions from the parent and coordinator. Contestants in the "Tiny" division must be out of diapers and potty trained as well as controllable by the parent so as not to be disruptive or hazardous to other participants in any way. The judges have the authority to advise the Queen committee that any contestant doesn't meet mandatory qualifications.**
11. If there are fewer than 3 contestants in any given age group, the committee has the right to cancel or omit that category for that year. If any age group proceeds with only one contestant, that contestant will have to earn a score of 75% or better in order to win the title. If the 75% or better score is not achieved, then the title will not be awarded. She will also have to score a 75% or better in each individual category in order to receive each category award. If a score of 75% or better is not achieved in the category the award will not be given.

**SELECTION OF HESPERIA WRANGLERS 2022 QUEENS**

**The selection shall be by majority vote of a panel of not less than three judges appointed by the Queen Coordinator and Hesperia Wranglers Board of Directors. Judges may give a total of 700 points as follows:**

1. Horsemanship – 250 points
2. Personality, poise and presentation– 150 points
3. Knowledge of the Hesperia Wranglers, current events, etc. (written test) - 50 points
4. Appearance– 100 points
5. Personal/Media interview – 150 points

**DIVISIONS of COMPETITION**

**HORSEMANSHIP**

There will be two go-rounds of horsemanship competition for the Junior Miss & Miss divisions. The first round will consist of riding a designated pattern and the second round will consist of small group rail work on draw horses provided by the queen committee.

1. Horsemanship: Control of mount and the way each situation that may occur is handled.
2. Balance- ability to sit in the saddle.
3. Position of hands, feet, and seat.
4. Mounting and dismounting.
5. Presentation wave/flag (Miss, Junior and Young).
6. Showmanship - This is how well the contestant projects her personality to the audience from horseback.
7. Contestants must be prompt to the entry gate. When your name is called, you must be at the gate and ready to ride. If the horse and rider do not enter the arena within 30 seconds, they will be disqualified.
8. Contestants may be questioned on each of the following categories: knowledge of tack, horse science, and the history of the Hesperia Wranglers.
9. There is to be no coaching from the crowd.

**Val Shearer Equestrian Center is closed to any equine other than those of contestants during the competition. On the day of competition please do not bring any other horse other than the one you will be competing on.**

Handlers of unruly horses will be asked to place the horse in a horse trailer or to remove the horse from the arena grounds. Stallions are not to be ridden by anyone under the age of 18 & therefore due to the possibility of switching of horses they will not be allowed for competition by anyone. No anabolic steroid is to be administered to a horse or pony in the time before the competition such that it, or any metabolite of it, might be present in the animal at the time of competition. This means that no anabolic steroids should be administered in advance or at the time of the competition.

**PERSONALITY, SPEECH AND MODELING**

1. Personality: friendly, outgoing, interacts well with and respectful of others.
2. Grooming: this should include neatness, cleanliness, fingernails, hair, hat, boots, and western apparel.
3. Poise: How the contestant carries herself is very important, the judges will be looking for contestants to carry themselves straight and tall and exude self-confidence and poise.
4. Judges will be looking for contestants to handle each situation that they are involved in with grace and style.
5. Proper fit of clothing: above all, contestants should pay attention to the fit of their outfit.
6. Conversational ability in varied areas with an emphasis on grammar and enunciation.
7. Demonstrates good sense of humor.
8. Self-confidence, high moral standards, sincerity, and integrity.

**WARDROBE GUIDELINES**

1. Each Contestant should have one complete horsemanship outfit with accessories. This should consist of monochromatic jeans, blouse (long sleeves and shirttails tucked in), cowboy boots, white or black felt hat, and belt with buckle. Spurs are allowed. No straw hats. I understand that the Pageant Director is not responsible at any time to wardrobe the contestants/titleholders. I will maintain clothing that is acceptable for a variety of appearances, at my own expense.
2. Each contestant will have one complete interview, speech and coronation outfit with accessories. Contestants may have the option of wearing jeans, slacks, or a dress/skirt during the interview. Speech outfit must consist of a dress or a skirt and top combination. Excessive fashion jewelry is discouraged. Tattoos and body piercing must be concealed at all times. No straw hats. I understand that the Pageant Director is not responsible at any time to wardrobe the contestants/titleholders. I will maintain clothing that is acceptable for a variety of appearances, at my own expense.
8. No chaps are to be worn for the horsemanship competition.

**APPLICATION REQUIREMENTS**

1. Each Contestant must supply the Hesperia Wranglers with an 8" x 10" photo. Photo must be a headshot photo in western attire. Western attire will include western blouse, suit or dress, hat, and accessories. Hesperia Wranglers shall have final approval of photos. Print the contestant's full name, age, year, and title which she is competing for on the back of each photo for identification. Outside headshots can work- they just aren't always the best option. Getting lighting right outside can be a challenge and the background may distract from YOU. They can work; it just presents a bigger challenge. Your headshots must also be in an electronic file, must be in a jpeg format. Please keep in mind that they need to be in high resolution so that they can be reproduced well in print for the program book. We want you to look your best.
2. Each contestant will provide own horse and tack necessary for the horsemanship competition. Draw horses for the Junior and Miss category will be provided.
3. Contestants will be expected to present a biography, which will be at **least** 10-12 sentences in length. The Hesperia Wranglers Queen Coordinator and committee will provide a speech topic for the speech portion of the competition. It is recommended that speeches are memorized, and no props will be allowed. A personal interview will also take place during the competition.
4. Contestants must provide their own transportation to and from all functions.
5. Contestants/ Royalty must sign the Hesperia Wranglers waiver and release form, the expectations form and complete the application. If under the age of 18, a parent or guardian must also sign the waiver and release form.
- 6. Contestants must provide own wardrobe.**
7. Contestants must provide access prior to application acceptance to Facebook/Twitter/Instagram/Snapchat and TikTok or any other social media account that they participate in whether it be public or private. Acceptance of the application will be contingent upon review of said social media by the Queen Coordinator and the committee. Any deemed inappropriate behavior in or on any public forum **can** be cause for immediate dismissal. **If a contestant is asked to remove postings, comments and/or pictures this should be done IMMEDIATELY. Keep in mind that these can be seen by the judges or any other member of the organization & should always represent a young lady that is wholesome & with good moral values. If said postings/pictures are not removed this may result in immediate dismissal from facilities or contest.**

**Application deadline: Sunday August 1, 2021 @ 6:00pm. Orientation will be contingent upon application acceptance and will be on August 18, 2021 at 5:30pm.**

**PHOTOGRAPHS** - Photographs taken of contestants during the contest and program, by program personnel will become the property of the Hesperia Wranglers and may be used for publicity.

**HORSEMANSHIP** - Hesperia Wranglers Miss and Junior contestants will ride a draw horse, Young, Junior and Miss Contestants are required to carry a flag as part of horsemanship; Tiny and Petite Contestants will **not** carry flags.

**SPORTSMANSHIP** - The Hesperia Wranglers expects each contestant, parents, friends, and relatives to display the highest degree of sportsmanship during the program, contest and following the coronation. Each contestant should be mindful that they are representing the Hesperia Wranglers and its family values. **Unsportsmanlike conduct or attitude will not be tolerated from either contestants and or parent(s)/guardian(s).**

Unsportsmanlike conduct or attitude could result in disqualification and affect further eligibility to compete in the Hesperia Wranglers Queens Contest.

**PROBLEMS AND COMPLAINTS** - Any problems and complaints should be immediately referred to the Queen Coordinator, committee member or Hesperia Wranglers Board of Directors prior to the week of the pageant. Anyone can report a problem or complaint to the Hesperia Wranglers Queen Coordinator, committee, or Hesperia Wranglers Board of Directors, and they will address the problem. **Unless timely reported each and every alleged violation of, and/or perceived violation of, contest rules and or regulations shall be deemed waived, and the complaining party shall be stopped from presenting allegations regarding the same.**

**STUDY INFORMATION** –Your local newspaper, television news, horse science books, Hesperia Wrangler history. Checking all social media regarding the queens is also highly recommended. These resources provide excellent information for study material.
