Communication:

Old Business:

- **Events-** we are replacing Figure 8 with Two-barrel cow horse.
- For those of you that have high school seniors, please don't forget that the William Kinard Memorial Scholarship applications are due no later than April 1st.

New Business:

- **Show Rules** Tonii reviewed the changes that were made by the show committee for this year...
 - 1. Cameras must be turned on for those attending via ZOOM, special circumstances will be considered prior to the meeting.
 - 2. Removed the "reserve champion buckles" from list of awards.
 - 3. Replace the word "offense" with "violation" regarding disciplinary action.
 - 4. Revised the verbiage regarding questionable soundness to "Note: A horse with questionable soundness issues will not be allowed to compete for the remainder of that day's show, and the rider will be required to supply a vet note prior to the next gymkhana indicating that the horse in question is sound enough to be used for gymkhana."
 - 5. Rule number 12 is now "A rider shall not enter the arena until the prior rider has COMPLETELY exited the arena. Horses must enter the arena under control and at a walk, or the rider will be excused from the arena and disqualified for that event. There is no alleyway. No more than one horse in the arena at any time, with the exception of Lead Line."
 - 6. Added verbiage to rule #23 regarding loping and warm-up of horses is restricted to the warm up area.
 - 7. Added verbiage to rule#31 regarding Green Horse and the fact that the horse cannot have won more than \$200 in cash and/or prizes.
- Amendment to the Hesperia Wranglers By-Laws voting- the amendment was approved by 100% votes in favor of the addition of definitions and verbiage change to Article VI, Section 2, paragraph 2.

Communications from the floor:

- Frankie- thinks we should see about putting on a team roping to benefit the club.
- Jessica- maybe set up a separate table for memberships.
