- Our queens were invited again to present the live auction items at Barn Bash and we would like to commit to a \$500.00 sponsorship this year and the queen committee approved that we do that.
- The Queen's "Cattle Drive" fundraiser is on Saturday, March 29<sup>th</sup> & the flyer has been posted on social media. \$50 per rider for ride & lunch and \$25 per person for just lunch.
- The Queen applications have been posted on our website and our flyer for the pageant has been posted on the website and our social media.
- We need to reimburse Kerri for creating our t-shirt design and getting them printed \$76.50 and the queen committee agreed to pay that as well.
