- Our entire queen's court had their official photo shoot last Tuesday with Elijah Schuller and Rena Ventimiglia, who both graciously stepped in due to Terri being under the weather. The girls all had a good time and with the photos Tonii was able to create official tear sheets for our Queen and her court.

- Our Miss-Krystal, Princess-Abby, Jr. Miss-Alyssa, Young Miss-Ashlyn, & our Sweetheart- Rebecca all did a great job representing us at the at the Tehachapi PRCA Rodeo and parade this last weekend.
- The girls are looking forward to attending the Intergenerational Dinner on Thursday at the Percy Bakker Center.
- Our Miss-Krystal and Jr. Miss- Alyssa will be riding in the Norco Mounted Posse Rodeo this Friday, Saturday and Sunday and our Young Miss- Ashlyn and Petite Miss -Annabelle will also attend and ride in the truck.
- The girls have an exciting opportunity coming up in November, which is an opportunity to have a photo shoot with Sherry Smith who is the official photographer for Miss Rodeo America, Miss Rodeo USA and other state rodeo queen pageants, including Miss Rodeo California.

#### **Old Business: Tim**

- Hesperia Days Rodeo is coming up and we will be needing volunteers.
- If anyone knows anyone interested, we still have club and rodeo sponsorships available.

#### **New Business: Tim**

- First thing is the Hesperia Days Parade- we are 30 days out from the rodeo and parade-we need to think about who is riding in the parade. We'd like to have a big showing of our organization, we are going to need at least 5 or 6 folks to carry rodeo sponsor flags as well as riders and walkers. If you are going to walk or ride, you'll need a red or white long sleeve shirts, no "river" hats, a felt or straw hat, or helmets and Tim even suggested that we have some folks that are just walking to ensure that everyone is staying safe.
- We need volunteers for the rodeo, Tim has a couple of young men that have volunteered, one is a William Kinnard Scholarship recipient and the other is also a Snowline student. We need folks to help oil the bucking chute gates, check the roping chute and boxes to make sure they're all in good working order, etc. We are also going to need some help putting a wire along the bottom rail to hold a banner along the bottom of the arena to keep trash from going into the arena
- **Recap of the most recent show-** we had over 40 riders at the last show, possibly close to 50 and we did good with the chuck wagon. The barrel race did really well also with 75 riders, 50 in the open, 20 in the novice and 7 peewees. It was a smaller course with a 40-foot score, and the course was about the same size as the one at South Point for the upcoming Buckles and Barrels for Bailey race. As a reminder we are only taking pre-entries for the September show and please remember that entries do close at noon on Friday so that Tonii can get everyone's work assignments done along with getting everyone entered.
- Tim- again as a reminder we are 30 days out from the rodeo and he will be down at the arena working on numerous projects in hopes of getting them done prior to the week of the rodeo. If you have it in your heart to volunteer, we can find y'all something to do. We found Brad a spot, with him cooking at the show and we truly thank him for that.
- Makayla- we need to take some pride in our arena, and we should try to get down there and help make the arena look good for our visitors. It would be nice for us to help make sure that our arena looks as good before the rodeo as it does after for our October show. We realize it isn't our actual home but it is our home arena so please let's try to help keep it looking good.

**Comments from the Floor:**

- Tonii- there is a proposal to combine the Secretary and Corresponding Secretary position within the By-Laws. According to our By-Laws we need to provide notice of the amendment to each member 30 days prior to the meeting at which they are to be acted upon which means we would need to present it at the September general membership so that it could be acted on at the October general meeting.
- Kimberlee- inquired if there was a deadline to sponsor the rodeo and Tonii suggested that if there is someone wanting to sponsor it would be better to get it in soon. She then asked about being a banner sponsor and if the sponsor needs to provide their own banner, which Tonii did say that banners are provided by the sponsor. Tonii also told Kimberlee that she would get her a sponsor packet and a poster from her car.
