New Business: Tim

- **Recap of the most recent show-**
 - a) Remember that complaints go to Tim & remember that Rule #1 is our show rules states that the Show committee/arena judge/Board of Directors decisions are FINAL. Rider may dispute any calls made but MUST DO SO PRIOR to leaving the arena. NO DISPUTES HANDLED AT THE SHOW BOOTH. Based on the incident that occurred at the show we need to review the Code of Conduct- we need to remember that we are all volunteers and it is important that we do not take our frustrations out on those volunteering. The most important items being #7- Use profanity, racial comments, demeaning language or inappropriate physical gestures or comments in any venue. This includes, but is not limited to, public events, emails, and/or social media of any type, and #8 Verbally attack or abuse any person, such as using profanity, racial comments, demeaning language, or comments that can be degrading. Keeping in mind that the Code of Conduct does stipulate Upon violation of any of the above articles of the code of conduct, Board members are required to **immediately** suspend the individual from further involvement and report actions to the Hesperia Wranglers President. Such person shall remain suspended until the Board has considered his/her case. Carol did ask if the rider isn't supposed to talk to anyone in the booth who should the rider talk to and Tim said that had he or Frankie had been in the arena then the rider could have approached either of them.
 - b.) Reminder, we do not have an alley and you need to walk into the arena before beginning your pattern.
 - c.) We all need to remember that when your class is called you need to be ready and everyone needs to do their part.
 - d.) Please remember to clean up after you load your horses, fill in your holes and if you're cleaning out your trailer please put it in the dumpster.
- **Hesperia Days-** Tim would like to make the parade a mandatory event so that we had a large group of riders and a good showing of our membership. This is your final chance to get your name on the list for riding in the Hesperia Days Parade, as of right now Melanie Loyd and Kerri Rodriguez have reached out for Bristol & Barrett and Lybertie & Natalie to ride and they would walk with their children. We also still need people to carry our rodeo sponsor flags in the parade.
