- Leanne, Lilly and Kailynn did a great job representing us at the Yucaipa Rodeo and the Sheriff's Kickoff trail ride on May 15th and 16th.
- Our contestants are busy getting all of the awards sponsored.
- Reimburse Tonii for postal fees \$50.50 for priority mailing payments to Carjo, Corriente Buckles, Barstow Pro Rodeo, Corriente Saddles and Archer Monograms.
- We owe Tonii's Discover card \$778.47 for the hides on the saddle stands and the hat cans.
- Kerri, Quannah and Tonii attended the Behind the Chutes clinic for directors this weekend, to see how to improve our pageant & we need to reimburse Tim's credit card for the clinic & hotel fees. We will also need to reimburse Tonii's bank card for the dinner while in Santa Maria and for pageant gifts from Michaels.

- We had new to us walkie talkie’s, with a wearable earpiece that we hope will make it easier for our trail boss and drag rider, donated by Mary Teran and new rechargeable batteries were purchased for \$24.99. This will make the total we owe Tim is \$249.49.
- Club banners- our current banners are old and we’d like to replace at least one in the 3’x 6’ so that we have the same size banner to hang at the rodeo which is typically less than \$40. We have a couple of banners currently but they are kind of small and one is even missing at least one letter on it. Daryl made the motion to replace the banner we currently have with a 3’x 6’ banner and Kerri 2nd the motion-M/C. Tim asked Tonii to order that.
- Discuss the rodeo sponsorship-the sponsorship for a buckle is now \$1,250.00. Tonii will talk to James about \$625 in a check and barter the remaining \$625 for the dirt work that Tim does, Tonii creating the sponsor package and does a lot of odds & ends during the rodeo and Kerri putting the rodeo program book together.
