TAHI NOWS ...From the Prez:



Where has the Year gone? 2019 seems like a blur when you look at all that has taken place at Texas Airstream Harbor this year. There some really good times but tough times as well. With everyone working together for the betterment of TAHI, somehow we managed to do what needed to be done.

As I reflect on the year there were a lot of accomplishments.

We were able to get the Blue Water tank on-line with new spray paint coating as required inside. Two new Water Plant pressure pumps were installed and a new well pump on water well number one after it was hit by lightning. New controls were also installed to replace some of the older equipment.

Around the clubhouse we installed a new back-up generator which will also run the sewer plant in the event of power loses. Clubhouse makeovers included a sliding glass door installed for a beautiful view of the lake from the dining area and a laundry renovation with new plumbing, paint and decorations.

On the down side of things, we had record high rainfall that produced record high lake levels which brought all kinds of debris to our shore line. Everyone pitched in to clean things up that included removing dangerous trees all around the park. The weather also delayed some road work which we had planned but were not able to repair.

In April our sewer plant was inspected by the TCEQ and we had very few issues that were brought to our attention. All in all we had a good report. In November the TCEQ came to inspect our water system which also passed with very few minor issues. A committee worked hard all year reviewing our Bylaws and

Ground Rules and have made numberous revisions or additions to make our park run better under new growth.

All these things required enormous amounts of time, all done by volunteers. We are very lucky to have a Board that works really well together backed by a tremendous amount of support from the membership. The Board is very aware of some issues and projects that weren't completed or even started, and are looking forward to moving forward with them in the New Year.

Let us not forget the TAHI Members who passed away this year moving up to Airstream Heaven. No doubt they're getting it ready for our arrival one day. I thank them for all they did for TAHI. We have much to be thankful for in the way of new members, with a wonderful diverse degree of expertise, ready and willing to contribute to TAHI.

Proposed Texas Airstream Harbor Bylaw Revision/Additions
For Membership Vote December 2019. This is a proposed additional article under
Ground Rules, Entitled Architectural Control (addition in bold)

Section

The Building Committee shall serve at the pleasure of the Board.

Section 2

The Building Committee must review and approve in writing all of the following projects on the Property:

• Construction of any building, retaining wall, shed

or other structure.

Any exterior addition, change, or alteration in any

building, wall, shed, or other structure.

 Any landscaping or grading of any lot or lots.

Section 3

Member must submit an application to the Building Committee showing the plans and specifications for the proposed work. Such plans and specifications shall detail the nature, shape, height, materials, colors, and location of the proposed work and shall contain a signed statement that the Member will follow the Corporation's building specifications. All structures must be white.

Section 4

The Building Committee shall review applications for proposed work in order to (I) ensure conformity of the proposal with these relations, conditions and restrictions, and (2) ensure harmony of external design in relation to the surrounding structures and topography. An application can be rejected for providing insufficient information. The Building Committee shall have broad, discretionary authority to interpret and apply these standards. In rejecting an application, the Building Committee should detail the reasons for rejection and suggest how the Member could remedy the deficiencies.

Section 5

Before any construction is commenced, the Member shall provide the Building Committee with a statement from the Member's contractor that the construction will be in accordance with the Corporation's building specifications. Member is required to be present at site for concrete delivery and foundation pours.

Section 6

The Corporation's building specifications are set forth in Construction Standards Document. Any variance in any construction must be approved by The Building Committee. The TAHI Board shall settle disputes regarding these matters. The owner must bear all liabilities if damage occurs to other property.

Section 7

Any electrical power requirements over 30 amps or more at 120 volts for an individual TAHI lot will require that the lot's electrical power be connected to an outside electric company service. The total cost of this electrical power transfer is at the expense of the individual Member who has use of the affected lot.

Section 8

The Building Committee shall have the right to inspect and measure any part of the exterior structure or lot at any stage of construction. If taxes increase due to construction of improvements, such increases will be paid by the Member affected.

Section 9

If construction plans have been altered or if any portion of the construction does not meet with the Corporation's building specifications, the construction shall stop, and the Member shall be requested, in writing, to make the necessary corrections.

Article III, Use of the Park, Section 9 (revision in bold)

Parking fees will be as follows:

\$20 per day \$120 per week \$400 per month \$2 per day or \$50 per month for dead storage — no hookups The sole exception to this is the \$10 per night charge for TGCU members on rally weekend. This will remain the same.

Additional items requiring membership approval:

Texas Airstream Harbor, Inc. Construction Standards, Architectural, p.4 (revision in bold)

A porch is optional; the porch area may be enclosed as part of the patio room. **Unenclosed porch areas, driveways, and sidewalks may be painted or stained concrete gray.**

Assessment Increase for January 2021 Increase annual Texas Airstream Harbor, Inc. assessment from \$600 per lot to \$700 effective December, 2020.

Page 8 Article VII Section 4

Quorum

A quorum of the general or special meeting of the membership shall be aminimum of eighteen (18) memberships qualified to vote. No membership shall be represented by proxy.

Page 16 Article V Section 3

Members may invite guest RV's of any make or brand, for not more than sixty (60) consecutive days per year, with the year starting on the date of arrival.
