NOTICE TO ALL LOCAL 30 MEMBERS

Re: Coronavirus – COVID-19

Re: Regular Monthly Dues

The COVID-19 pandemic has caused widespread financial uncertainty. Many of our members are struggling to make ends meet. In response to this crisis, the International Association has granted per capita dues relief to each of its local unions for the month of March 2020. Per capita dues are the amounts that local unions pay to the International Association each month.

In light of the International Association's decision to grant dues relief to its local unions, **Local 30 has decided to grant each of its members two (2) months' credit in respect of "over-the-counter" monthly dues.** This credit will be applied to the next two months' dues that a member would otherwise owe. In other words, if a member has paid dues up to and including the month of April 2020, then that member will be considered paid up to and including the month of June 2020. Please note that if you participate in the local union's pre-authorized dues deduction program, those deductions will continue unless you choose the option set out below. Similarly, if you are employed and your employer deducts and remits your monthly dues, those deductions will continue unless you choose the option set out below.

Important Information

Option - Pre-Authorized Dues Deductions - If you participate in the local union's pre-authorized dues deduction program and you want to have your two (2) months' dues credit take effect by having the local union suspend those deductions for the months of May 2020 and June 2020, please notify the local union of this option via e-mail at info@smwia-L30.com by **April 30, 2020**. Please note that if you choose this option the pre-authorized dues deductions will resume in July 2020.

Option - Employer Check-Offs - If you are employed and your employer deducts and remits your monthly dues and you want to have your two (2) months' dues credit take effect by having the local union request that your employer not deduct monthly dues during the months of May 2020 and June 2020, please notify the local union of this option via e-mail at info@smwia-L30.com by **April 30, 2020**. Please note that if you choose this option and the Employer stops your deductions for May 2020 and June 2020, deductions will resume in July 2020 if you remain employed at that time.

Please note that the two (2) months' dues credit only applies to members whose monthly dues are currently paid up to and including the month of January 2020, or after.

I am pleased to announce that this action of the local union has been unanimously approved by Local 30's Executive Board. Together we can overcome the obstacles that come with these challenging times. In closing, I would like to remind everyone to please stay safe and look out for each other.
