### **PAYMENTS**

Your statements are separated into **Regular Assessment**, **Road Project Assessment**, and **Lien Fees**. When making payments, please state where you want your payment to be applied. For example, if you make a \$500.00 payment note \$300.00 for Regular, and \$200 for Road Project if you would like it separated that way.

Proof of payment will show on your statements which are sent out monthly on the 15th. If you make a payment after the 14th it will not show until the following month.

**CRD**- Credit
