

Fancoin Purchase Instructions:

1. All initial purchasers of Fancoin tokens must complete this purchase form and user application.
2. This is a PDF fill & sign form and should be completed using Adobe Acrobat Reader.
3. Download this purchase form to your device/computer, open the file using Adobe Acrobat Reader, fill in all of the blanks, and email the form to us. Incomplete forms will be rejected.
4. Click [Email Form](#) and attach the completed form you saved to your device/computer. Purchase forms can also be sent via fax or overnight mail.
5. Upon approval of your user application you will be sent a secure email with your user account information, an invoice for the number of Fancoins purchased and payment instructions.

FANCOIN PURCHASE FORM AND FANCOIN EXCHANGE USER APPLICATION

This Fancoin Purchase Form and Fancoin Exchange User Application (“**Purchase Form**”) certifies the undersigned purchaser (“**Purchaser**”) has agreed to purchase Fancoin tokens (“**Fancoins**”) on the Fancoin Exchange (“**Fancoin Exchange**”) according to all terms and conditions contained in this Purchase Form and the Fancoin Exchange website.

1. Fancoin Exchange User. Purchase of Fancoins is subject to review and approval of Purchaser as a Fancoin Exchange User (“**Fancoin Exchange User**”). You as a Fancoin Exchange User applicant must make your initial purchase of Fancoins using this Purchase Form. Upon your approval as a Fancoin Exchange User you can subsequently purchase Fancoins directly on the Fancoin Exchange website using your Fancoin Exchange User account.

2. Purchase Amount. The minimum number of Fancoins that can be purchased is 1,000 Fancoins. There is no maximum number of Fancoins that can be purchased. Purchaser desires to purchase a total number of Fancoins equal to (insert number greater than 1,000) (“**Fancoins Purchased**”).

- a. The Fancoin Exchange agrees to waive all fees for the initial Fancoins Purchased, however all subsequent purchases shall be subject to Fancoin Exchange standard buy and sell transaction/service fees collectively ranging from 1% to 7%, or more, depending on transaction size.
- b. The price per Fancoin is equal to the **buy price** per Fancoin quoted on the Fancoin Exchange website at fancoinexchange.com on the date the Purchase Amount as stated below is paid in full by Purchaser (“**Price Per Fancoin**”).
- c. The total purchase amount is calculated by multiplying the Fancoins Purchased by the Price Per Fancoin in USD (“**Purchase Amount**”).
- d. Upon approval as a Fancoin Exchange User you will be sent a secure email containing an Invoice for the Purchase Amount with payment instructions.

Upon payment of the Purchase Amount you will be sent the following documentation:

- a. Fancoin Ownership Accounting Statement showing your User Account information, current Fancoin transaction, and Fancoin transaction history.

- b. Fancoin Exchange Ownership Certificate showing owner of record, the number of Fancoins owned, and number of Fancoins held as collateral in the Fancoin Exchange treasury escrow account as of the certificate date.
- c. Updated copies of the Fancoin Exchange Ownership Certificate and Ownership Accounting Statement will be sent for your records each time a transaction increases or decreases your Fancoin holdings including purchases, sales, or Fancoin additions resulting from coin splits or treasury escrow loss coverage.
- d. Your Fancoin Exchange Ownership Certificate and Ownership Accounting Statement together with your User Account provides you with comprehensive and detailed documentation regarding your initial Fancoin purchase, updates for each subsequent transaction as well as complete account history.

3. Fancoin Exchange Terms & Conditions of Purchase and Use. Purchaser acknowledges it has reviewed and expressly agrees to all terms and conditions contained on the Fancoin Exchange website at fancoinexchange.com including all website text, exhibits, attachments and downloadable documents, the most important of which are the Fancoin Exchange User Agreement, Fancoin Exchange Purchase Agreement and Fancoin Exchange Privacy Policy.

The Fancoin Exchange is a fully independent entity from Fanbase Inc., which is the sole developer and owner of the Fanbase mobile and desktop software application. The only Fancoin tokens that can be purchased, sold or traded on the Fancoin Exchange are those that have been originally mined by Fancoin Exchange approved third-party miners. All Fancoins purchased on the Fancoin Exchange can be utilized without limitation on the Fanbase mobile and desktop software applications.

Purchaser agrees that Fancoins involve a high degree of risk, no market may exist to sell Fancoins in the future, and it is capable of sustaining a loss of its Purchase Amount.
