I request that you promptly process this request in full compliance with FOIA requirements. As detailed in my request, I am: ✓ Invoking expedited processing under 5 U.S.C. § 552(a)(6)(E) due to potential due process violations and legal urgency. ✓ Demanding a Vaughn Index if any redactions or withholdings occur under FOIA exemptions. ✓ Requesting a sworn affidavit from the Records Custodian if records are lost, missing, or destroyed. ✓ Demanding a full review of any claim of Exemption 1 (National Security) or Exemption 7 (Law Enforcement Records) as this case is closed, and no ongoing investigation exists. ✓ Requesting a full fee waiver under 5 U.S.C. § 552(a)(4)(A)(iii) due to the public interest and my financial status. Compliance Deadline As per FOIA law, you are required to respond within 20 business days from receipt of this request. If additional time is needed, you must provide written justification explaining the delay as required by 5 U.S.C. § 552(a)(6)(B)(i)-(iii). Notice of Legal Action for Non-Compliance Failure to comply with this FOIA request, unreasonable delays, or wrongful denial will result in immediate legal escalation, including: A formal FOIA appeal under 5 U.S.C. § 552(a)(6)(A)(i). A lawsuit under 5 U.S.C. § 552(a)(4)(B) in U.S. District Court for unlawful withholding of records. A formal complaint with the Office of Government Information Services (OGIS). This request is being made in full compliance with FOIA and is legally enforceable. I expect full cooperation and transparency in handling this matter. Please confirm receipt of this request at your earliest convenience.
