

### President's Corner

It is hard to believe it is the fifth month of the '95 reenacting season and already a part of the association's membership have been on the campaign. The Holmes Brigade and other Federal contingencies gathered for their annual spring muster at Ft. Scott, Kansas.

It would seem that James "Red Leg Lane" Beckner set the woods on fire. If "Red Leg Lane" Beckner is not burning out honorable Missouri farms, he will turn on his own clan. Once a pyromaniac, always a pyromaniac, or once a "Red Leg" always a "Red Leg."

A large majority of the Confederate 4th Battalion traveled to Ft. Blakely, Ala., to participate in the 130th anniversary of that siege. It was an honor to be invited and also to command the garrison there. The event took place on the same date, day and time of the original siege. At the battle of Ft. Blakely the Missouri Brigade made it's last stand and pasted into the pages of history. The experience was a hallowed one, as we were in the original entrenchments.

A number of items came about with the Ft. Blakely event that we can all learn from. The event sponsors had worked for two years to make this event a reality as this will probably be the last time the event will come about due to land developers wanting the sight. The event sponsors needed to bring this to the forefront and prove to the park service that reenactors could be trusted and be worked with to keep the sight pure. These objectives were met but with difficulty.

There were two battalions for the event, the 4th Battalion and another Confederate contingency from Alabama, Florida and Georgia Bringing these personalities together was

quite the task. This contingency battalion wanted to run their own program opposite the event sponsors and command structure. Just before the final siege, the Georgians pulled from the event saying that they did not do large battles. They had come to campaign in the woods and wanted to be totally separate from the event sponsors' wishes.

This caused more than one problem. This idealism ran against the published program, communications were nil, and safety was low since these people ran their own campaign. These actions jeopardized the future of Ft. Blakely, the integrity of their own unit as well as the other units upon the field. Most importantly, there was no honor for those who have marched before us. This was Lexington, Missouri, all over once more.

There is room in the hobby for everyone--civilians, scenarioed events and campaign events--but we must all be on the same sheet of paper. This sheet of paper should be preservation through historical interpretation. This can be accomplished through communication, cooperation and remembering what our objective and purpose is. We must keep in mind, that the event should always be the primary focus, not the individual ego.

#### Maysville May 27-28

The Maysville, MO event set for May 27-28 has a new contact person in Rod Archdekin of Crowley's 3rd Missouri Infantry (1-816-233-9985).

The MCWRA sanctioned event is expecting about 300 participants, will provide all regular amenities, includes several provided meals, and has a parade set on Saturday.

To get to the site (from south) take I-35 to Missouri 36 West, and then on to 33 north into Maysville. Go west on Highway 6 approximately 8 blocks and find the signs for the site, which is about 3/4 of a mile from that point.

## \*\*\* Moore's Mill updates

Plans are progressing towards providing members of the MCWRA with a first rate event at the Battle of Moore's Mill reenactment July 14-16, located 7 miles east of Fulton, MO, near Calwood.

The maximum event has scheduled two guest speakers--Juanita Leisch and Les Jensen. Leich is a nationally known expert on ladies and civilian clothing of the 1860's, and an author, who will be autographing copies of her new book, Who Wore What: Women's Wear 1861-65.

Jensen is chief of collections at the Center of Military History for the U.S. Army, and was an editor of the Time-Life's Civil War series. He is considered an expert on CS jackets and the depot system.

Limited edition souvenirs will be available at the event, including a commemorative book with info on the Kingdom of Callaway, a bronze campaign medal and a key chain.

## Scott Hughes reports treasury in very good shape

(Because of the large membership, MCWRA minutes are mailed to Board members and then published in full in *The Western Campaigner* for general information.)

The location of the meeting was changed from Lohman's Landing to the Library, and was held March 11.

Meeting was called to order by President-Elect Steve Allie as President John Beck was unable to attend.

Secretary Janet Hussey led the pledge of allegiance. As the minutes had been published in *The Western Campaigner*, reading of the minutes were waived, but the following corrections were noted:

• Erwin's 6th MO, Company A, taken off probabation, were sponsored by the 4th Missouri and not the 5th.

• "The Town" is the official unit name. Jim Beckner moved that the minutes be approved as amended; Bob Smith seconded. So moved.

Treasurer Scott Hughes reported that dues were coming in rapidly and the treasury was in very good shape, but did not have current balance with him. Jim Beckner suggested that this report be accepted and that the current balance would be reported in *The Campaigner*. (UPDATE: The current balance on hand as reported by the treasurer is \$12,738.00. The 1995

insurance premium is still to paid out of this amount, and memberships continue to come in.)

Scott Hughes moved and Bud Marvin seconded that the 8th Missouri Cavalry be taken off probation. Motion passed.

The following units were placed on probationary status:

- Northwest 15th Arkansas Regiment, Infantry, Company A, CSA sponsored by 4th MO Infantry.
- Elliott Scouts Dismounted Cavalry, CSA, sponsored by Shelby's 5th MO Cavalry
- 9th Kansas US Cavalry, Company G, sponsored by 4th MO Volunteer Cavalry, USA

#### **Old Business**

Steve Allie explained that a motion had been tabled at the November meeting regarding the possibility of MCWRA paying the liability insurance rather than the event sponsor. This would allow the MCWRA to have more control over the events, and also remove the burden of insur-

ance payment from smaller event sponsors. The MCWRA treasury is in a position to assume these insurance payment. MCWRA current insurance covers only ten events per season, and those ten events will be the ones covered in 199S.

Event sponsors over and above these ten covered events would have to pay their own MCWRA coverage (this is yet another reason for event sponsors to get dates and requests in early) or possibly could be added into the coverage by vote of the Board.

It was again restated that this insurance is only liability coverage if a spectator is injured by an MCWRA member during an event. Maximum, sanctioned and local events voted on by the Board at the planning meeting can be covered by insurance. Listed events are NOT covered and are published merely for the information of the membership. National events cannot be insured by the MCWRA as the insurance company feels MCWRA does not have enough control over such events.

After discussion on this matter, Henry Johns moved that MCWRA pay the insurance for events on the schedule for 1995 and continue to do so until policy changes or the treasury cannot bear the burden. Terry Cadenbach seconded; motion carried.

#### New Business

The date for the Columbia living history event was moved to June 10-11. Dennis Faught moved and Henry Johns seconded that it be calendared on that date. Motion carried.

During the planning meeting, MCWRA voted to list Lone Jack as a maximum effort if the date could be moved to August 19-20. It was reported that this date was tentatively scheduled; membership should watch *The Campaigner* for final announcement. Henry Johns moved, and Jim Beckner seconded that IF Lone Jack is indeed scheduled for August 19-20, MCWRA will support it as a maximum effort.

Henry Johns announced that the Department of the Army Corps of Engineers was planning a Civil War event on July 8 & 9 and asked that it be listed. Contact Henry for additional details.

An event in Malvern, KS sponsored by 4th MO was requested to be listed; for further information contact George Hill 812-264-2557.

St. Charles, MO will have an event on September 9 & 10, 1995. Bob Smith was happy to announce that activities will again be located in the riverside park. They requested that St. Charles be listed as a LOCAL event and they will pay their own insurance. Bob Smith moved, Henry Johns seconded and the motion carried.

Charles Zeller reported on a listed event in Chester, IL in Kaskaskia Park on the River, August 19-20, 1 llb. powder to first 200; contact Ted Mueller, 618-826-3035.

Fred Norris reminded the membership of the Wilson Creek Moonlight Tour.

President-Elect Allie again reminded those attending of the importance of firm dates when sponsors request a maximum event listing. In order for the MCWRA to encourage large attendance at maximum events, enough time must be allowed between maximum events so that reenactors can realistically be expected to participate. Once those dates have been voted on, a rescheduling is unfair to other events which received votes on

their status based on the dates involved.

Case in point, Lone Jack 1995 was voted on as a maximum event with the contingency that the date be changed, and with that possible change in mind, Glasgow was given a maximum event vote. However, had the date not been changed, both events would have lost attendance. Date rescheduling also makes it difficult on latecomers who plan even listed events based on the published calendar. It was also discussed that maximum events be limited to a certain number each season so that MCWRA members can make every effort to support maximum events.

To reiterate the categories: MAXI-MUM events indicate that 800 or more reenactors are expected and can be provided for; that both sides and all types of units are invited; and that the activities, setting etc. are within MCWRA standards. MCWRA members are strongly urged to participate.

SANCTIONED events fall within MCWRA standards for setting, authenticity, etc. but are not able to accommodate the large numbers and/ or the scenario does not include certain units for one reason or another (no room for artillery or cavalry, for instance).

LOCAL events are similar in criteria to Sanctioned events, but on a smaller scale. However, the "local" designation must be voted on by the Board. "Listed" events are any type of event or living history which are listed in *The Campaigner* for the information of the membership. They are not insured by MCWRA, or are required to follow any particular MCWRA guidelines, and the MCWRA does not vote on these.

Henry Johns suggested that the newly formed Event Council meet and decide the number of maximum events per season, more precise calendaring requirements, etc. and report back to the Board and membership.

A DNR representative was present at the meeting; he and interested parties were to meet after the MCWRA meeting regarding Pilot Knob. Unless otherwise notified, Pilot Knob is still scheduled for September 23 & 24.

This will be further discussed at the general membership meeting before being put to a vote.

The calendar planning meeting will be held at the Jefferson City Library at 10:00 a.m. on Saturday, August 26, 1995.

Terry Cadenbach moved, and Henry Johns seconded that the meeting be adjourned. Motion carried.

## \*\*\* Glasgow event highlights

The max effort event at Glasgow, MO August 4-6 is being sponsored by the Glasgow Historical Society and Collins Battery.

US and CS infantry, artillery, cavalry and civilians are needed, with Friday registration set from 8 a.m. to 7 p.m. At 7:30 p.m. that evening, the reenactment of the events that took place at Glasgow from Sept. 14 to 21, 1861 will come alive.

Drills and demonstrations will be held throughout Saturday morning, with a parade set at 10 a.m. for all participants through downtown Glasgow.

A ladies fashion show will be held on the lawn of an antebellum home at 11:15 a.m. and at 2 p.m. all units will come toegether on the battlefield for the reenactment of the 1864 Battle of Glasgow. A wine tasting tent will be provided, along with modern craft vendors, and period displays and demonstrations on Water Street.

At 3 p.m. the Platte Purchase Players will present "Soiled Dove Revue" at the outdoor period saloon on Market Street.

There will be a twilight firing Saturday evening, followed by a period ball on the antebellum home's lawn, with music by the 4th Artillery Quadrille Ensemble.

Normal amenities are being provided, with powder to the artillery, ice and free admission to the ball for all reenactors registered. The historical society is providing a home tour Saturday and Sunday for the town's antebellum homes, with a fee charge.

Campsite and battlefield will be the same as the 1992 event on 50 acres, with parking in a 15 acre field across the street from the campsites and battlefield. Modern camping will be in a lot adjacent to the East Acres Motel 500 yards from the site.

I received several issues of the newsletter of the 15th Arkansas Inf. and the 14th Alabama Infantry. This is another well done, newsy sheet that is invaluable on an individual unit scale in keeping the various unit members in contact and in the know.

## Letters to the Editor



Dear Editor:

Before someone writes in wondering what we are doing with mountain howitzers in a cavalry unit let me explain. I joined the Army in 1964 and went through basic infantry training at Ft. Wood. I was then sent to Ft. Sill for artillery survey training, then advanced artillery survey training, then to Officers Candidate School.

My father, an old first sergeant, thought second lieutenants were the lowest form of life on the earth, so afler completing the first two parts of the training, I dropped out and was sent to Korea as a surveyor for the 1st Cav. We were a fast moving Honest John unit, on alert all of the

During that time I served as a forward observer and part of a fire safety team. From Korea I was sent to Fort Carson, Colorado, for a short time. From there I was sent to Fort Gordon, Georgia, for military police training and then back to Fort Carson for duty. I first did regular patrol duty but was then assigned to the stockade as the sergeant in charge of maximum security cells. From there I was sent to Alaska as a desk sergeant and then back onto a survey crew for the Army Map Service.

What I am trying to say is that I have a great deal of military experience, and I try to look at each problem from more than one point of view. I know from experience that rules are bent if not broken when necessary, and the one who does bend the rules is either a hero or a heel, only time tells.

I have found that during the Civil War, one reason the men west of the river lasted as long as they did is because they didn't fight by the rules. Now this is how this country got its freedom in the first place, but when the ancestors of those first freedom

fighters did the same thing in the Civil War, they were viewed by the other side as heels, not heroes. We could have mistaken those dissenters as British if they hadn't been standing on American soil and waving the Stars and Stripes.

I cannot prove that the 3rd Missouri Cavalry Battalion had any mountain howitzers, but they could have, and that is why we have them in our unit. I believe I also have the experience, as a technician with a degree in electro-mechanical technology and 20 years experience, to build and train a crew to safely operate these guns.

Now don't misunderstand me. I do make mistakes, but don't get in my face and be wrong and expect me to keep quiet as I have done in the past. I won't.

These mountain howitzers will be run with a four man crew, without horses for now. You can assume that the fifth and sixth men are in the woods with three horses. We are using the Manual For Light Artillery for our standards, and we are building our guns from original plans. We have at this time two guns built and three in the planning stages, two of which are started.

Each gun will be assigned to its home company, two in Pleasant Hope, one each in Mountain Grove, Fair Grove, and Willow Springs We hope to have each gun pulled by one horse at some time and followed up with a horse with two ammo boxes.

#### Monnett conveys land

The Monnett Battle of Westport Fund, Inc., has conveyed ownership of nearly 100 acres of the Civil War battlefield site at Byram's Ford on the Big Blue River to the Kansas City Parks and Recreation Dept.

The signing ceremony was held April 29 at Loose Park. The ceremony culminated 12 years by the preservation organization in acquiring important parcels of land which saw heavy fighting between Union and Confederate troops Oct. 22-23, 1864.

Plans are for the KC Parks & Rec. Dept. to operate the battlefield site as a historic city park.

In 1991 the Monnett Fund received a \$21,000 challenge grant from the Assoc. of the Preservation of Civil War Sites, Inc., which allowed the preservation of an additional 40 acres to go with the nearly 60 it already owned.

Had the blast been a couple of inches lower, or I a couple of inches taller, I might not have the eyesight with which to write this letter.

I am not writing to preach about safety or even that occasional stupid blunder that gets someone hurt. I am writing, however, to say thank you to the several anonymous boys in gray

who saw what happened and rushed to my assistance.

I want to also mention Mark Strother of the Holmes Brigade. Mark refused to leave my side until I was eventually released from the first aid station. It was these guys who washed off my forehead, got help and kept me calm until the Paramedics arrived.

For their compassion, care and brotherhood, I am very grateful.


