#### 1. Unauthorized Access to Summerhill Home(s) and attempts:

Yesterday (September 1<sup>st</sup>) a man was knocking on Summerhill Area Home doors between 7:00am and 8:30 am He appeared to be selling some newspapers or delivering parcels. He rang the bell and spoke with the homeowner if s/he answered. If there was no answer he would try the door. In one case that I am aware of he found the front door unlocked, entered and stole a wallet. He was in and out of the home within two minutes. (One homeowner was out at an early appointment, the partner was walking the dog around the block.) Through email communication with immediate and surrounding Summerhill neighbours his actions were caught on several video cameras going from door to door. As he looked liked he was selling or delivering newspapers one neighbour said hello to him. Later as the emails were distributed amongst neighbours one neighbour had noticed a man stash a bag in the shrubs at the garden by the subway and go into the subway. Inside the bag was the wallet minus the money and credit cards. The man was later making purchases at Spadina and Bloor. No one was hurt in this incident HOWEVER it is a reminder to keep your doors locked. (police have been informed)

Within 5 minutes someone went into the backyard and removed the bike(s).

Below is a picture of that <u>'appears"</u> to be the man identified as the attacker. I do not have an update at the time of writing if the man has been apprehended or if the attacks continue in our area.



#### 5. Dogs of Leash – email from Councillors Office

Below is an email from the Councillor's office

"Our office has been receiving emails from residents about dogs off leash in park areas (and on the <u>City sidewalks</u>) where they <u>are</u> <u>not</u> <u>permitted to be off leash</u>. We have had numerous complaints

Due to the pandemic, park and residential street usage has increased and this includes an increased number of seniors and children as well as adults. It is particularly difficult for this group to manage dogs off leash. Enforcement at the parks has been requested and kindly ask that a reminder be sent through your networks to residents that dogs can only be off leash in designated areas for everyone's safety and well-being and that dog owners need to clean up after their pets".

#### 6. Litter Collection in the Ravine

This spring, Parks, Forestry and Recreation began litter collection in hotspot ravine locations in the city, as a key next step to the implementation of the Ravine Strategy. Litter collection was part of the Ravine Strategy Implementation staff report that was adopted by City Council on January 29, 2020.

This spring, litter collection work focused on known hotspots across the city that have been identified through complaints to 311, as well as by staff. Through the summer, more litter picking is planned in the ravines. We just learned that staff plans to be in Toronto and East York District, including our ward, between August 17 and September 11.

The SRA identified areas of concern in our area to the Councillors office for the initial clean-up.

Please note after this clean up if you notice litter a complaint should be made to 311. A Picture and an exact location (as much as possible) should be made available for ease of finding the debris and garbage. Make that call or write that email so as to keep up with the Ravine tidy.

I received a note yesterday from staff that the path to the ravine at Shaftesbury has been cleared. Please see photo attached. I am now working on determining whether low-no maintenance planting can take place so that we mitigate further dumping along the path. Will follow up with you when and if I make headway on that"

This is great news



#### 7. Notice of Construction Completion: Mud Creek Restoration - Reach 6 (Phase 2 and 3)

Hello Councillor Robinson and Councillor Layton,

Toronto and Region Conservation Authority (TRCA), in partnership with the City of Toronto, has now completed the channel restoration works along Mud Creek Reach 6 (Phase 2 and 3), which commenced in fall 2019. Some before and after photos of the work can be accessed <a href="here">here</a>.

Due to the upcoming switchback project in this area (Beltline Trail Improvements at Moore Avenue), some fencing and temporary measures have been left in place. The site has been restored in the interim and the trail will remain open until the switchback project commences. "Feedback that I have received has indicated that homeowners have seen less or no rats for the last few weeks". This is great as we do not want them in our homes this winter.
