

# Firefighter II Course Syllabus

#### Overview

This course contains approximately 45.5 hours of self-paced online learning, and 48 hours of in-person skills-based instruction with 8 hours of certification evaluation. The course prepares the student to become certified as a Fire Fighter.

The Firefighter II Program can be entered as an individual course not part of a certificate or diploma program for individuals already employed in the emergency services industry. The tuition fees for signing up for the Firefighter II course individually are:

- Firefighter II Online: \$991.38
- Firefighter II Practical: \$2,206.62

# Course Prerequisites

- Legal Right to work in Canada (or international student application)
- Proof of age (minimum 18 years of age or Junior Firefighter agreement signed by parent/guardian)
- English Language Proficiency (in accordance to the CFRC Language Proficiency Policy)
- Signed Medical Clearance form (filled out by physician)
- Valid Alberta Class 5 Drivers License with air brake endorsement (Or equivalent)
- High School Diploma, GED, or mature admission status
- Standard First Aid and CPR Level C (or equivalent)

# Outcome Objectives

After completing this course the student will have met the sections required for a Fire Fighter II in the NFPA 1001, 2019 edition, Standard for Fire Fighter Professional Qualifications. Students will not be eligible for certification testing unless they have first received their NFPA 470 (1072) Awareness and Operations, and Firefighter I certifications from IFSAC and/or the Pro Board.

# **Textbooks Required**

The required text for the course is IFSTA's **Essentials of Fire Fighting**, Seventh Edition. Students are also required to purchase IFSTA's **Essentials of Firefighting**, **Seventh Edition Student Workbook**. This workbook is to be completed in the weeks proceeding a scheduled practical component, and throughout the practical component itself. Books can be ordered from the AFCA Bookstore. # Homework Assignment

Homework will be assigned on a case-by-case basis by the instructor. Students will be required to complete chapters in their **Student Workbook** as assigned by the instructor on evenings and on weekends during their practical component. This book should NOT be completed by the students in advance, and only chapters assigned by the instructor should be completed by set deadlines. Failure to complete homework assignments may result in disciplinary action, and or dismissal from the program at the discretion of the instructor.

# Pre-Course Assignments

Students must complete the online course components (ICS 100, Firefighter II Online) prior to attending the practical component. Students who have not completed the online course work prior to the start date of the practical classes will be dismissed from the program. If not previously certified as a level I firefighter, students must also complete the Firefighter I Online course prior to attending the practical component.

# of Skills Tested	Up to 159 skills may be tested during evaluation. The skills are randomly selected from 159 skills by the certifying agency. Each skill is pass/fail. One attempt to re-try a particular skill may be granted by the evaluator if deemed appropriate.

All final examinations are proctored and evaluated by a third party who operates on behalf of an IFSAC or Pro-Board certified agency or association.
