Autumn kicks off the major Ham Radio Contest season. Two of the year's biggest events are the ARRL November Sweepstakes and the CQ Worldwide.

Contesting is a great way to improve your operating skills and a great excuse to upgrade your station. It's also your best opportunity to work some new States or DX Countries.

This year CQWW SSB is October 26th-27th, and CW is November 23rd-24th. Sweepstakes CW is November 2nd-4th, SSB is November 16th-18th.

New -- or even not-so-new -- to Radio Contests? Click here for some tips on how to make the most of them. Every licensed Ham has at least some operating privileges on the HF Bands, and with the sunspot cycle improving daily this year's events should provide a whole lot of fun.

# New to Contesting? Here are some tips for you.

I'm at best a casual contester. My modest station includes a 100W HF rig and a wire antenna up about 30 feet. Squarely in "Peanut Whistle" territory, for sure, compared to many others. But I do enjoy getting on the air and working stations all over the US and the world. With just a bit of effort,

you can often get your Worked All States, or DXCC Award, in a single weekend. If you're new to HF, or contesting, here are ten tips for you. What?? You still haven't passed your General Class License test? Take a look at my tips for passing here. Find an exam session and join the fun.

- #1. Read the contest rules. Understand what bands you can use, what your entry category will be, and what the "exchange" is. Simply, that's the information you will give to the other station and he/she will give to you. In the CQWW, for example, you send them a signal report and your CQ "Zone". Since I live in the Eastern US, I'm in Zone 5, so I would send "59 05". Note that by tradition, in a contest everyone has a 59 or 599 signal.
- #2. Get with the program. Specifically, a logging program. There are quite a few options out there. My personal choice is the N1MM Logger It's free and has an amazing array of features. It's updated regularly and has an extremely active online support community. It also interfaces with just about any modern HF radio you might own.

There is a bit of a learning curve involved, so you don't want to wait until the last minute to install it and familiarize yourself with it. Get it now, connect your rig, and spend a little time with it. You might want to start a "fake contest" -- select CQWW, for instance, and enter some calls. Get to understand the entry window, and what other windows you might or might not want open during the contest. After you enter a few dozen fictitious contacts, make sure that the program will produce a Cabrillo file with an accurate score and summary. Hint: If it doesn't, the problem is in your setup, not the program itself. And finally -- don't get into the habit of hearing a station, writing his call and info down on paper, and then entering it in the computer. This only wastes time and leads to more mistakes. Enter it straight into the program. And if you already have logging software installed, make sure you have the latest upgrades and support files installed and working.

#3. More Butt-in-Chair-Operating-Time = more contacts. Turn off distractions like texting, Facebook, e-mail, TV, broadcast radio, etc. Concentrate. But don't forget to take breaks. For 5 minutes every hour, get up, stretch,

get some fresh air and a glass of water or a cup of coffee.

- #4. Set an achievable goal. Face it. If you're not an experienced contester with a "Big Gun" station (yet!) you're not going to win. But you can certainly try to beat your score in last year's contest. Or work DXCC in a weekend. Or outscore your buddy across town.
- #5. Study propagation forecasts and get a sense of what bands are likely to be open to areas you want to work, and at what times. This will help you come up with a basic plan. But remember that band openings can occur at any time, so if you're operating in a category that allows it, keep an eye on the DX cluster because those openings can often be brief but intense.
- #6. Don't waste time in pileups early in the contest, especially if you have a Little Pistol station like mine. Sure, give those rare ones a call or two, you may get lucky. But you're competing with guys running plenty of power into big antennas. Go back to them later in the contest, after they've worked all the Big Guns. Often enough they'll be begging for contacts and you'll work them easily.
- #7. Work those Mults! Most contests include "multipliers" in their scoring system. Basically, your score is calculated like this: You get a set number of points for each contact. Then, depending on the contest, you get one mult for each country, or each state, or each something that you work. Multiply your points by the number of mults, and that's your total score. You can see that each mult makes a much bigger difference in your score than another contact in the same country or state. Again, read the rules for the contest you're operating in.
- #8. Know Those Knobs! Try to familiarize yourself with the controls on your radio. Just about every rig has an attenuator, a pre-amp, an RF Gain control, and a noise blanker. Most also include an IF shift or pass-band tuning adjustment. An old trick that QRP (very low power) operators use is to turn OFF the pre-amp and turn ON some attenuation. That may seem counter intuitive. But now if a station is loud to you, the chances are much better that you're also loud to them. Let their big antennas and high power do the "heavy lifting". Similarly, turning down your RF gain can

knock down a nearby (in frequency) Big Gun so you can work a weaker station.

#9. Use standard phonetics. My call is N1GNV. Years ago, I enjoyed having a small vegetable garden. It was kinda fun to announce my call as No One Grows Nicer Vegetables on the local repeater or among Ham Radio friends. But in a contest, that only causes confusion and mistakes -- and is considered poor practice. November One Golf November Victor is what the other guy is expecting to hear. In noisy or otherwise difficult conditions, I might say "Golf November Victor, Germany Norway Victoria" but that's about it. Standard Phonetics in contests, always.

#10. Listen before you call. Make sure you've got the other station's call and exchange. You can even pre-enter it in your logging software. Listen to his pattern. Does he say "QRZ?" after each contact? You want to make sure you're transmitting when he's listening. Work him (making sure he's got YOUR call correct!), hit enter, and he's in your log. Move on to the next one.

#11. Bonus Tip: Many Hams travel to rare locations and assemble stations just for the major contests, particularly CQWW. In the days leading up to the event, they'll be testing their equipment on the air. That can be a great opportunity to test your own setup and snag a few more countries at the same time.

Finally -- this is a hobby. It's supposed to be FUN!! Enjoy the contest, and I hope to work you on all the bands.





### **Directional Antenna Positioning Information**


#### Declination

The angle between magnetic north and true north. Declination varies by location. In North America, declination ranges from 30° east in Alaska to 20° west in Labrador, Maine. Most GPS receivers can calculate declination for the current position.

#### North Star

The North Star, also known as Polaris, is a reference point for true north. Because the North Star appears almost stationary in the sky, it's a useful navigation tool. GPS uses radio signals from satellites to calculate a receiver's location on Earth. The North Star is located directly above the North Pole, so pointing towards the spot on the horizon directly below it indicates north.


Why do people use the North Star to navigate?



Fortunately, there is one star in the night sky that does not appear to move. It is called Polaris, or the North Star. It is directly overhead the North Pole. This means that whenever we point towards the spot on the horizon directly below the North Star, we must be pointing north.

How many degrees off is magnetic north from true north?

#### West Declination



Map Bearing = Magnetic Bearing - Declination

Depending on where you are, the angle between true north and magnetic north is different. In the U.S., the angle of declination varies from about 20 degrees west in Maine to about 21 degrees east in Washington.

When positioning a radio antenna, it's best to use true north instead of magnetic north. This is because the difference between the two, known as magnetic declination, can vary depending on your location.

True north Magnetic north

Definition Static and located about 1,200 miles north Constantly shifting pole that the Earth's magnetism of the magnetic pole attracts a compass needle to

To accurately align your antenna, you need to compensate for your local magnetic declination. You can do this by adding the absolute value of a west (negative) declination to your compass reading or subtracting it from your compass reading for an east (positive) declination.

While you might not be able to align your antenna exactly to true north, most antenna beam widths are broad enough that you won't see much difference if your heading is a few degrees off – especially for HF yagis. However, for high gain long-boom VHF/UHF antennas, it's important to align your antenna to true north.

Wayne - WA1PMA, and XYL Donna - WA1VWA (SK), have a long history of membership and support for CARA and CARA's repeaters. Wayne was instrumental in the installation, maintenance, and upgrades of the then 147.120 MHz. WR1ADN repeater, which was owned by the Pioneer Valley Repeater Association - PVRA. PVRA still owns a network of repeaters throughout CT like KB1AEV and NARA.

Wayne was involved from its origin in Roxbury in the early 70's, then throughout several re-locations to New Fairfield (120 Ft. tower in a field adjacent to New Fairfield HS) Dave - W1LRC's QTH on Karen Rd. in Danbury, Danbury Hospital (roof superstructure), including hosting it at his home in Newtown (110 Ft. tower) for several years before the shipping container was retrofitted, then airlifted in the 80's via CT National Guard helicopter to the summit of Spruce Mtn. where it's located today.

When CARA dissolved it's multiple-year relationship with the PVRA, the frequency was also changed. A repeater group nearby in New York installed an uncoordinated competing repeater, so CARA moved W1QI yet again to the present 147.300 MHz. frequency.

Along the journey, our CARA repeaters have signed K1BYD, N1FIH, and Donna's callsign - WA1VWA (SK) before W1QI.

CARA Constitution and By-Laws December 1, 2024 (10/7/24 V)

#### **Preamble**

The Full Membership of CARA, being desirous to secure for ourselves the pleasures and benefits of the association of persons commonly interested in Amateur Radio, by furthering better cooperation among its members, develop individual proficiency, furthering the interest of radio in the general community, do hereby

constitute or	urselves	as The	Candlewoo	od Amateur	Radio

#### Constitution

#### **Article I – Name and Purpose**

The name of the corporation shall be Candlewood Amateur Radio Association, INC., hereinafter referred to as "CARA.". CARA, is organized as a Connecticut non-stock corporation exclusively for charitable, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### **Article II - Mission**

CARA, seeks to comply with and support the purposes of the Amateur Radio Service as defined in the Federal Communications Commission Rules Part 97.1. It seeks to expand public understanding and appreciation of the Amateur Radio Service, encourage men and women to participate in this service, provide emergency and public assistance communications services, assist and improve the technical skills of its members, assist those who seek to become FCC licensed amateur operators, contribute to the advancement of the radio art, and to otherwise support charitable and public goodwill efforts. CARA will accomplish these purposes through volunteer activities of its membership, financial support of charitable and educational opportunities, and public benevolent efforts.

#### Article III – Leadership elections and removal

**Section 1** The Officers of CARA. shall be a President, Vice-President, Secretary and Treasurer. There will be three (3) Directors of CARA. Candidates for office in CARA shall have a valid Amateur Radio license, be a full member in good standing and those candidates for the role of Director must have a minimum of 4 years of continuous membership.

**Section 2** The Directors and Officers of CARA shall be elected for a two-year term by ballot of the members present, provided there be a quorum as defined in By-Laws; Elections shall be held at the June Annual meeting.

**Section 3** Vacancies occurring between elections must be filled by special election at the first regular business meeting after the withdrawal or resignation is announced.

**Section 4** Officers may be removed on a motion by two thirds (2/3) vote of membership present and voting at the meeting, provided that: a) a special meeting has been requested to address the removal issue; b) the special meeting has recommended a motion to remove; c) the officer has not resigned. d) the motion is voted on at the next regular business meeting; e) a quorum is present at both the special and the regular meeting. All financial authority of the officer being considered for removal shall be suspended until the matter is resolved.

#### **Article IV - Financial Matters**

**Section 1** CARA may levy upon the membership such dues as shall be deemed necessary for the business of the organization within its objectives as set forth in the Purposes of the organization.

**Section 2** CARA from time to time, may participate alone or with other organizations in fund raising activities to supplement member dues.

**Section 3** CARA may accept donations from the membership or the public to be used in the accomplishment of the Purposes of the organization. Financial donations shall be designated by the donor for a specific purpose or general fund use. CARA may accept equipment donations.

**Section 4** No part of the net earnings of CARA shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that CARA shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of CARA shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and CARA shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, CARA shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### **Article V - Amendments**

**Section 1** This Constitution may be amended by a two thirds (2/3) vote of members present and voting if a quorum is met. Proposals for amendments shall be submitted in writing at a regular business meeting and not voted on until the next regular business meeting. A

quorum as described in the by-laws must be present at the meeting.

#### **Article VI - Rules**

**Section 1** The CARA Executive Committee and Directors shall carry the duty to ensure that Robert's Rules of Order are executed to govern all proceedings of CARA.

#### **Article VII - Dissolution of CARA**

**Section 1** Upon dissolution of CARA, assets shall be distributed to one or more amateur radio related exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code if possible.

#### **By-Laws**

#### **Article 1: MEMBERSHIP**

**Section 1** All persons interested in Amateur Radio shall be eligible for membership in CARA.

Section 2 Full Member- shall consist of those individuals who are over the age of 16, hold a valid FCC Amateur Radio license and are members in good standing. (Good Standing is defined as one who has paid their annual dues no later than March 1<sup>st</sup>). Only Full Members are eligible to vote at regular or special meetings as determined by the club Secretary or Treasurer.

**Section 3** Licensed Amateur's under the age of 16 or those interested in Amateur radio but unlicensed can apply for an Associate Membership.

**Section 4** At the sole discretion of the board and officers, Auxiliary membership may be bestowed upon a non-dues paying individual. **Section 5** Associate and Auxiliary members have no voting rights and are not eligible for any elected leadership positions.

#### Article 2: Club Elected leadership

**Section 1** The Elected Officers and Directors of CARA shall be: (President, Vice-President, Secretary, Treasurer) and 3 Directors. Their two-year term as Officers and Directors shall be from July 1<sup>st</sup> to the end of the second year June 30<sup>th</sup>.

#### **Article 3: Leadership Duties**

**Section 1** The President shall preside at all meetings of this organization and conduct the same according to the rules adopted; he/she shall enforce due observance of these By-Laws, and Robert's Rules of Order; decide all questions of order; sign all official documents that are adopted by the organization; and perform all customary duties pertaining to the office of the President. He or she shall, at the expiration of his/her term, turn over everything in their possession belonging to the organization to his/her successor.

**Section 2** The Vice-President shall assume all the duties of the President in the absence of the latter. He or she shall, at the expiration of his term, turn over everything in his/her possession belonging to the organization to their successor.

Section 3 The Secretary shall keep a record of the proceedings of monthly business or special meetings, keep a roll of members, and submit applications for membership, carry on all correspondence, read communications at each meeting, and notify membership by reasonable communication means of every special meeting of the organization, except when excused by action under the By-Laws. The Secretary shall keep the CARA Constitution and By-Laws and have a copy on hand at every business and special meeting. He or she shall cause all amendments, changes, and additions to such. He or she shall, at the expiration of his/her term, turn over everything in his possession belonging to the organization to their successor, both written and in electronic format.

**Section 4** The Treasurer shall receive all monies paid to the organization; and shall keep an accurate account of all monies received and expended. He or she shall pay no bills without proper authorization which occurs at a business meeting. At the

end of each month, he or she shall submit an itemized statement of disbursements and receipts. He or she shall file the required IRS Form 990 tax forms relating to CARA 501c3. He or she shall, at the expiration of their term, turn over everything in his/her possession belonging to the organization to their successor in both written and electronic format.

Section 5 The Directors are integral to the overall management of CARA. Directors are encouraged to attend all business meetings and activities meetings. The Directors shall biannually present a slate of Officers and Directors for the next term at the appropriate May meeting. The Directors shall annually review the Financial Books and Records of the organization.

#### **Article 4 Meetings:**

**Section 1** An Activities/Event meeting and a Business meeting shall be held each month at such time and place as the President shall order, or as agreed upon by a vote of the Full Members. The Business meeting is where all spending motions, annual dues motions will be discussed and voted upon, and reports of the various committees shall be made. Each month there will be an Activities/event meeting to further the purposes of CARA and amateur radio.

**Section 2 Quorum Requirement**: A quorum necessary at Business/Special meetings is defined as 7.5% of the total full membership plus two officers and or directors.

**Section 3 Special meetings** may be called by the President upon the written request of any five (5) members or two (2) Directors of CARA. Notice shall be sent to all the members informing them of the special meeting and business to be transacted. Such notice shall be made by reasonable

communication means, minimum of 72 hours prior to the meeting. Only such business as is designated in the said notice shall be transacted at such special meeting.

**Section 4 Lack of Quorum-**When a motion is brought forth at a business or special meeting without the necessary quorum present, notification by reasonable communication means shall be made to all members by the Secretary stating the proposal that will be brought up at the next meeting for vote. Reasonable means of communication shall be made within 72 hours of the business or special meeting. Reasonable means of communication shall include the use of Email/Electronic Voting.

**Section 5** A majority vote of the officers and directors may spend up to \$500 without a formal motion at a business meeting.

**Article 6 Dues:** Membership dues are due January 1st of the current year. Membership status and membership privileges will be eliminated if dues are not paid by March 1<sup>st</sup>.

#### **Article 6: STANDING COMMITTEES:**

CARA shall create the following Standing Committees listed below. Each committee shall have a chair. <u>All</u> business and activities shall be assigned to one of the four standing committees.

#### Procedure:

The four CARA Standing Committees shall meet as deemed necessary by the Committee chairman and shall submit written minutes at the Monthly Business meeting. The Monthly Business

meeting agendas shall be structured around the work and progress of these four CARA Standing Committees.

Each full member shall be encouraged to serve on The Administrative Committee and one other Committee of their choosing as part of their CARA membership.

The Officers and Directors shall be responsible for determining that Full members are appropriately aligned to each of the four committees.

Four CARA Standing Committees:

## Administrative Committee: Handle routine business of the club

- Monthly Business Meeting agenda submitted for publication in CARA Capers
- Annual Dues
  - Recommends any dues abatements to Board of Directors for their unanimous approval.
  - Enforcement of the dues payment deadline policy
- Communications and Information Subcommittee
  - Website maintenance and oversite
  - Management of social media accounts
  - Submit information to Newsletter Editor/Staff on a timely basis.
- Newsletter

Prepare and electronically distribute the CARA Monthly Newsletter on the Monday of the week when the monthly business meeting will be held.

- Membership
  - Maintenance of the Official CARA membership list (paper and electronic)
  - Arranging (pair) new members with volunteer Elmer

- VE Testing
- Organize and conduct Amateur Radio License classes when appropriate.
- Administration of the CARA-Sponsored Worked All Connecticut Counties Award
- Prepare and award Certificates of Appreciation for meeting guest speakers and when appropriate for other contributions.
- Other business-related activities of the club
- Submit the annual report to the State of Connecticut and Federal Government to maintain 501(C)3 status
- Submit the annual club report to the ARRL as part of the ARRL Special Service Club requirements
- CARA W1QI Club License and Trustee Responsibilities:
  - Maintain and renew the W1QI FCC license
  - Maintain electronic logs when W1QI is used (Field Day, Special Event Stations, or activations by members)
  - Members shall advise the W1QI Trustee prior to use of the CARA W1QI club callsign on the air and submit electronic documentation to the W1QI Trustee.
  - Establish and maintain the W1QI <u>www.QRZ.com</u> account and biography page on a routine basis
  - Maintain the W1QI TQSL key and upload logs to ARRL's LoTW – Logbook of the World W1QI account

## Repeater Committee: Maintain CARA Repeaters and Coordination

- Arrange periodic meetings and perform projects related to repeater maintenance as required and upgrades after approval at business meeting.
- Provide periodic reports on the progress of repeater projects and repeater maintenance.
- Other repeater related activities of the club
- Maintain the CARA Repeater registration requirements as specified by the local coordination body.

#### **Fund Raising Committee:**

- Prepare a proposal for and other related details to the membership for discussion, vote and approval.
- Provide a detailed financial summary by the next scheduled monthly business meeting.

# Program and Activities Committee: Plan and execute arrangements for Guest speakers for meetings and events and plan other activities.

- Conduct an annual interest survey to guide programs and determine Guest Speaker invitations.
- Create a Preliminary CARA Calendar to inform membership of upcoming programs and activities.
- CARA Field Day
- CARA Winter Field Day
- Coordinate any other Special Event Stations that may arise
- Schedule CARA's monthly Pasta Night
- Schedule Annual Holiday Party
- Administer CARA's Parks on The Air (POTA) activations.
- Determine the ways and means for participation in other operating activities, workshops, demonstrations, and drills as voted by and supported by membership volunteers
- Where equipment and facilities permit, establish, and maintain a Club or Remote Station for CARA members to use.
- designated members may provide emergency and public assistance communications services
- Other program or activities that may be of interest to the club

#### <u>Article 7 – By-Law Amendments</u>

**Section 1** The By-Laws may be amended by a two thirds (2/3) vote of members present and voting. Proposals for amendments shall be submitted in writing at a regular business meeting and not

voted on until the next regular business meeting. A quorum as described in these by-laws must be present at the meeting for the vote.
