## **DISPLAYS & EXHIBITS**

The Danbury Railway Museum is in the heart of Danbury, Connecticut.



Our fully restored train station, built in 1903, houses a collection of historically significant artifacts and a research library covering railroading's rich heritage in New England and the northeast United States. Just behind the station is an extensive rail This month's meeting is Friday May 10<sup>th</sup> at yard, featuring over 60 pieces of historic railroad equipment and rolling stock. The round. Family-friendly rides aboard our historic trains are offered every weekend between April and December, and special event trains are operated for Easter, Autumn, and Christmas. Welcome







Our museum is home to an ever-growing collection of railroad artifacts and objects. On display inside Union Station, you'll find

railroad lanterns, china and silverware, timetables, tools, historic photographs, uniforms, telegrams, and model trains. All these items help illustrate the impact railroading has had in New England and our region.



Just outside and across the tracks is Danbury Railyard. Our 15-track, 10-acre historic yard is home to over 75 pieces of railroad rolling stock and locomotives. For a full roster and details on each piece of equipment, click here.

By far the largest artifact associated with our organization is Danbury Union Station, which serves as our main display space and welcome center. Our city has been associated with railroads since May of 1850, when a charter was granted to the Danbury & Norwalk Railroad. The first regular train service began in March of 1852. Over the next several decades, railroads in New England continued to grow, linking emerging industrial centers, farm regions, and large cities together.



By the 1880s, Danbury was home to three railroads, each with its own station. The Danbury & Norwalk Railroad's station was on Main Street on the same plot of land where the Post Office is now, the New York & New England Railroad's corporate offices and former station still stand as part of the Leahy Fuel Company, and the Housatonic Railroad's station once stood on the north side of the Maybrook freight line. All three would become part of the New York, New Haven & Hartford Railroad fresh bakery products. Today, this room in 1892.



In 1896, the 'loop' track was constructed to connect the old Danbury & Norwalk line with the former New York & New England Railroad tracks. The construction of Union Station followed, and it opened its doors on July 13, 1903. The new 'L' shaped building was said to be the largest station on the railroad's New York Division. south made Danbury an ideal terminal The spacious waiting room is accessed through a 12-foot-wide brick archway. The west end of the room features a fireplace accented with subtle floral-patterned brickwork, and the room originally also had a lunch counter in the southeast corner. The long benches in the main entrance hall are all original to the building. The baggage room was in the northwest corner of the building; today it serves as our Gift Shop. The Adams Express room was in the southwest corner.

This was later known as the Railway Express Agency; they were a conglomerate of the railroads that handled the shipping and delivery of packages, trunks, and even houses our research library and archives. In the middle of the station you'll find the ticket and telegraph offices, used today for museum administrative purposes.



Timetables from the early 20th century report that about 125 trains passed through town daily. Key destinations like Pittsfield, Mass. to the north, New Haven to the east, Maybrook Yard to the west, and Norwalk and New York City to the location. In 1925, the tracks to Norwalk were electrified with overhead catenary, allowing for direct service to Grand Central Terminal. After World War II, both freight and passenger traffic began to diminish. Once the Interstate Highway System was built, shipping by truck became more feasible and people began traveling by car.



Alfred Hitchcock filmed portions of his 1951 film Strangers on a Train in Danbury. He chose Union Station to play the part of Metcalf Station because of its curved platform and central location in a 'fairsized city.' Around this time, general maintenance would start to be overlooked. It survived the floods of 1955, whose high-water mark was 4 feet above the waiting room floor. By the mid 1950s, the canopy sagged so badly that it was reported a fireman getting off a train injured himself by walking into it. It would soon be stripped from the building and disappear before the end of the decade.



The railroads that served Danbury fell on hard times too. The New Haven Railroad

went into bankruptcy, and on January 1, 1969, it became part of the Penn Central Railroad. In the 1970s, the building was slated to be torn down as part of a redevelopment plan for downtown. When the Nixon administration withdrew federal funding for the redevelopment project, the building was spared. The Penn Central would soon fail, and in 1976, the federal government acquired the assets of it and five other northeastern bankrupt railroads to form the Consolidated Rail Corporation, commonly known as Conrail. On September 25, 1986, the station was added to the National Register of Historic Places. Conrail became profitable in the early 1980s, and was sold off to CSX and Norfolk Southern in 1999.



In the early 1990s, the Connecticut Department of Transportation wanted to build a new high-level railroad station that would meet the standards set forth in the Americans with Disabilities Act (ADA) while also serving the commuting public more efficiently than the now-condemned Union Station. They could not rehab the existing building, because the sharp curve of the tracks would not allow for a highlevel platform. The City of Danbury would perform a land swap with the state; a parcel of undeveloped land on the opposite side of the loop track for Union Station and the parking lot.



In 1992, the City of Danbury received a federal ISTEA grant of \$1.5 million to restore the station back to its 1903 appearance. The project was completed in 1995, and the building was dedicated on October 29th of that year.

Our museum has occupied the building since 1996, and while it is no longer an active passenger station, Metro-North commuter trains continue to pass by the curved platform every day.



In 1991, well after all the lucrative hat industry that long supported the city was gone, downtown Danbury, much like many other smaller downtowns, was in decline. Danbury Union Station had become so dilapidated that Metro North was only using the ticket office portion of the crumbling 90 year-old building. Danbury Mayor Gene Eriquez began to focus on resolving the issues facing his downtown.



The city of Danbury began by performing a land swap with the State Department of Transportation, trading an underdeveloped plot of land by the iconic 'gas ball' for the now condemned Union Station building, and several non-railroad hungry for a railroad attraction, Mayor uses were proposed for the new city property. Around the same time another railroad preservation organization based out of Old Saybrook, Connecticut had outgrown their Essex facility and was looking to relocate. Union Station and the under-utilized freight vard looked attractive to them and the city was interested.

So, the Railroad Museum of New England and the City of Danbury began talks. The public responded favorably to the proposed 'Danbury Railroad Heritage Park,' an October 6, 1991 Danbury News-Times editorial remarked that the RMNE could be 'an anchor' in 'a rejuvenated downtown Danbury.' In the summer of 1992, the city was awarded a 1.5 milliondollar ISTEA grant for the restoration of Union Station, things seemed to be moving in the right direction. But in early February 1994 negotiations fell through, the RMNE moved on and would eventually plant a flag in Thomaston Connecticut.



The City of Danbury still had an eyesore of a building and an empty rail yard, both at a high visible location in the downtown area, and both with no viable tenants. Still

Eriquez turned to members of the Western Connecticut chapter of the National Railway Historical Society and challenged them to come up with a proposal to make use of the city's rail assets. Within days the late Peter Cornwall and the late John Flower presented the mayor with a proposal for a new museum. This organization would "inform and educate the public about the vital role railroads and railroaders have played." The city accepted the proposal and the Danbury Railway Museum was incorporated as a not-for-profit organization in March of 1994.



The museum began life in an empty storefront at 16 Ives Street and for the first year this was home. In May of 1995 we signed a lease with the city making us the sole tenant of the rail vard. It was only one month later on a Snowy April 8th that the Housatonic Railroad made a special delivery of five coaches, then owned by the Connecticut Department of Transportation and leased to us. With the delivery of the Coaches came the surprise donation of an ex-New Haven Railroad gondola.



Before long the rail yard collection was growing, Metro-North Donated two Budd Rail Diesel Cars, then two Burro cranes. In January of 1996 we bought our first locomotive, an American Locomotive Company model RS-1 from the Green Mountain Railroad of Vermont. The end of operate a railway museum in Danbury, CT, February saw our first caboose, an ex-New Haven Railroad class NE-5 that saw service in the Danbury area in its working life and now in retirement.



As the vard came back to life, the restoration of Union Station continued. In April of 1996 we left lves street and moved into our new home, the fully **Restored Danbury Union Station at 120** White Street. Since then our collection has

grown, not only the yard, but also to include artifacts, books, pictures, blueprints, railroad timetables, and other periodicals. Most of the paper collection is made available for viewing to researchers and historians through our research and reference library.

Today we're one of the few museums open year round, and from April to November vou can ride The Railvard Local. This short and sweet ride has proven to be a hit with younger visitors. After your ride feel free to tour the rest of the Railyard and see the now over 60 pieces of equipment on property.

## Mission

The purpose of the Corporation shall be to to educate the public as to the history of railroading and to the role of the railroads as part of our local and national heritage, and to engage in any and all activities convenient to said purposes.

The Danbury Railway Museum is a 501(c)(3) non-profit organization staffed entirely by volunteers. The Museum's ongoing preservation efforts are funded by memberships, donations, grants, and museum admissions. If you are interested in railroad history in New England, we encourage you to become a member or volunteer. On-the-job training is available for all volunteer positions, including train crew!



## CARA's 2024 Technician Licensing class by John Morelli – W1JGM

In early January 2024, I was approached by friends interested in Amateur Radio for various reasons. I spoke to them about the many facets of the hobby, from being able to communicate locally, statewide, worldwide and even to astronauts on the ISS. I explained the activities the amateur radio community is involved with. There was significant interest, so I explained how to get started and what it takes to become licensed. There was a spark of interest, so I approached the CARA club to sponsor a class and agreed to organize and help conduct it.

Three other CARA members offered to assist as instructors: John Ahle - W1JMA, Dan Thiel – N2DGT, and Vincent Tompkins – N2OHH.

We met several times and planned the curriculum, agenda, required supplies and venue to hold the in-person classes. CARA has been conducting weekly Elmer/Mentor sessions for club members on Sunday evenings via MS Teams, so we decided on a hybrid approach, that would combine in-person and on-line sessions. We gathered interest from potential students and instructors and started the class at the beginning of March with ten students and four instructors. Our first class was an in-person session, where many questions were asked, and expectations of the class and other details were explained. The course textbook was supplied by Bud Kozloff – W1NSK, our ARRL CT Section Manager and CARA President. He arranged for them and they were partially paid for by the CARA club. Arrangements were made to use the Ball Pond Volunteer Fire Company in New Fairfield as the venue.

After several virtual Sunday evening classes, we met in-person on a Sunday afternoon for a hands-on class and demonstration. Various amateur radio equipment was demonstrated, which included two live stations on 10 meters. One was used for sideband and one on FT8 digital. Student interest peaked when some 10-meter DX came rolling in. We called on one of the local repeaters with an HT and received a reply from another ham 50 miles away, leaving no doubt that our students were hooked.

We continued the class virtually and included another weeknight class so that additional material could be discussed, and questions answered.

The final exam was conducted on April 21 by a combined Volunteer Examiner (VE) team from the nearby Northville Amateur Radio Association - NARA, and CARA VE team. ARRL's Field Services Manager, Mike Walters – W8ZY, is also a member of both organizations.

The license exam was conducted by using the new on-line HamStudy.org web site. It was interesting to observe the testing in real time using the on-line method.

The VE team tested the class and two additional walk-ins, resulting in adding 9 new Technician - level licensees and two General class to the Amateur Radio community.

Congratulations are in order to the new hams:

Many thanks go to the instructors that assisted in conducting the class: John Ahle - W1JMA, Dan Thiel – N2DGT, and Vincent Tompkins – N2OHH.

I'd like to also extend thanks to Gordon West – WB6NOA, who inspired me and provided information and insight for me to lead my first Amateur Radio training class. Thank you, Gordo for all your help.

The Candlewood Amateur Radio Association – CARA, is already considering conducting a General class starting January 2025 to upgrade our new and current Technicians.

CARA recently applied for and was granted renewal of their ARRL designation as a Special Service Club.

# New England QSO Party – May 4-5, 2024

## Rules

**Object:** To contact as many New England stations (Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, Vermont) in as many New England counties as possible on 80-40-20-15-10m. (New England stations work anyone)

Date: First full weekend of May (May 7-8, 2022, May 6-7, 2023)

**Contest Period:** 2000Z Saturday until 0500Z Sunday (4pm EDT Saturday until 1am EDT Sunday) and 1300Z Sunday until 2400Z Sunday (9am EDT Sunday until 8pm EDT Sunday).

**Categories:** Single-operator high power, low power(150w or less) and QRP(5w or less) categories, plus multi-operator, single transmitter and multi-transmitter. Mobile categories are the same except not Multi-Multi. Use of spotting assistance and self-spotting is permitted in all categories.

**Contest Exchange:** Send signal report and state/province (DX stations send signal report and "DX"). New England stations send signal report, county and state.

**Valid Contact:** Work New England stations once per band/mode. New England stations work anyone (and must copy the county for New England stations worked). CW contacts must not be made in the phone band segments. Mobiles that change counties are considered to be new stations, and can be worked for both multiplier and QSO Point credit. County line QSOs should be logged as two separate QSOs. Crossmode, crossband, and repeater QSOs are not permitted.

**QSO Points:** Count one point per phone QSO, two points per CW (includes digital modes)QSO.

**Multiplier:** Stations outside of New England use <u>counties</u> as multipliers for a total of 68 (CT/9 MA/14 ME/16 NH/10 RI/5 VT/14). New England stations use states(50)(Count DC as MD), Canadian provinces(14 – VO1/VO2 are separate) and DXCC countries as multipliers. Note that CT switched from counties to Regional Councils of Government (2024).

**Scoring:** Total score is QSO points times the multiplier. Mobiles count QSO points per county and multipliers from all counties (counted once).

**Suggested frequencies:** CW – 3540 7035 14040 21040 28040, SSB – 3850 7180 7280 14280 21380 28380.


## What Happened to Connecticut Counties?

A long time ago (1960) Connecticut eliminated county government. County names have remained "on the books" and on maps ever since, and mostly used to deal with interactions with the US Census and other Federal programs. Every square inch of the state is within the boundaries of 169 different towns where local control is the basis of most local government decisions. Over the years, a series of regional planning districts (Council of Governments) have been assembled to deal with regional transportation, air quality and other areas where cooperation between towns is necessary.

In 2019, the state formally requested that the US Census Bureau approve a proposal to recognize Connecticut's nine planning regions as the statistical equivalent of counties for the purpose of tabulating and publishing future Census data. This went through a two-year review process and was finally approved in mid-2022. This year (2024) will see the first release of data based on regional planning districts.

The New England QSO Party will recognize the change beginning with the 2024 NEQP. This change will add one multiplier in CT, making for a total of 68 in New England. We will work with software authors to make sure that the "county" change is reflected in current software versions. There will be several other contest rules changes as well, noted elsewhere.

There may be some confusion with those giving NEQP contact information and with those outside of New England. The log checking process will make sure that all entries are scored the same way, with the same list of 68 multipliers.

# LED vs. CFL Bulbs: Which Is More Energy-Efficient?

This chart can help make changing from watts to lumens easier. We match the watts you're familiar with against the ultimately more useful lumens metric. More lumens equals more brightness. When replacing incandescent bulbs, here's a quick breakdown of how wattage translates to lumens:

Replace a 100-watt incandescent bulb with a 1,600-lumen bulb. Replace a 75-watt incandescent bulb with an 1,100-lumen bulb. Replace a 60-watt incandescent bulb with an 800-lumen bulb. Replace a 40-watt incandescent bulb with a 450-lumen bulb.

#### Choosing the right light temperature

The last thing to consider is the temperature of the light emitted by different kinds of light bulbs. Light temperature, often seen as color, is measured on the Kelvin (K) scale.

The lower the Kelvin temperature, the redder the light. The higher the Kelvin temperature, the bluer the light appears. Candlelight is on the red end of the spectrum at about 1,900 K. Incandescent lights average 2,800 K. The daylight sun is about 4,800 K. LED and CFL light bulbs use filters to offer a range of light colors to fit the desired feel of a room or to support a room's purpose.

Tasks and Responsibilities – 10 Step Planning Document



The purpose of this document is to provide details of tasks and responsibilities involved with the CARA 2024 Field Day activity, which is scheduled for the weekend of June 22-23, 2024.

CARA members are encouraged to sign-up for multiple items to ensure that all tasks are adequately covered.

## This is your club – it only works with TEAMWORK.





The level of involvement and commitment will directly affect the planning for, and execution of this event.

CARA 2024 FD Leadership Team:

This Team will consult with the Executive Committee concerning decisions based on the membership commitments made and adjust the scope of our annual ARRL Field Day event as required.

## 1. Coordination with Field Day Site officials:

Establish contact with site officials. Ensure CARA compliance with site regulations concerning access, times on site, parking, clean-up, and other details.

## 2. FD Entry class & Radio Equipment:

Determine FD entry class. Determine/arrange for station locations and shelter(s). Determine station equipment needs & arrange transportation. Arrange and perform set up/take down for stations. Create Excel checklist indicating items and sources. Confirm FD stations are operational before FD begins. Install ground rod(s) for station(s). Provide N1MM Logger + common operating hints (documentation) for both stations. Provide equipment manuals for operator reference.

## 3. Antennas:

Propose and finalize antennas based on number of stations and related factors. Create setup documentation (diagram of what will be used, and where it will be installed) Antenna selection and placement should allow optimum flexibility in band selection and performance, with minimal co-interference if multiple transmitters are used. Attach labels to each FD station antenna. Attach safety streamers to antenna supports, cables, feedlines and other antenna components to ensure safety compliance. Ensure that CARA bandpass filters are installed correctly and provide information related to their use at FD stations. Install/take down antennas. Arrange for transportation of CARA antenna assets including antennas, rope, and coaxial cable feedlines to/from storage at the Bethel EOC.

## 4. Operator shifts and event coverage:

Create a *Sign-Up Genius* format using web application. https://www.signupgenius.com/go/20F054AA8A923A7F58-49094286-field/167048084#/ Ensure that the entire time we're committing for is covered. Extent of FD operation based on Sign-Up Genius response by CARA membership. Answer questions and communicate information related to operator shifts. Distribute and update often via CARA Groups IO, providing timely updates and communications with CARA FD Leadership Team.

## 5. Logging Computers:

Ensure that CARA logging laptop computers are prepared and configured with N1MM+ Logger program for logging FD contacts during the operation. Establish a **wired Ethernet** network for FD use. Arrange/provide IT support during the event.

## 6. Supplies/Food/beverages:

All details regarding FD supplies budget, requisition/transportation of supplies etc. Means for on-site cooking, refrigeration, etc. Set up/take down of field kitchen/food preparation. Historically, several members have provided FD food, with a "donations basket" for member contributions to cover expenses. Food/beverages has **not** been included in FD financial planning nor budgeting. However, 20 ARRL Field Day pins are usually purchased via CARA funding as an incentive for member participation. (based on sign-up and completion of tasks and responsibilities outlined in this document)

## 7. Field Day Public Relations:

Plan and deploy Visitor/Greeter canopy/table during the event. Set up a canopy outside (preferred & weather permitting) in front of the FD Site. Greet visitors, provide information, conduct station tours, answer questions, hand out CARA brochure, CARA Membership Application & ARRL information, etc.

## 8. Safety Officer(s) & Security:

Mark all hazards on the FD site including coax cables, antenna supports, ground rod wires, etc. Attach (tape) cables to floor or tape to walls to eliminate trip hazard(s).Ensure that fire extinguisher locations are known by all. Ensure that a properly equipped First Aid Kit is available during the entire FD event.

**Perform all the requirements listed on the ARRL Safety Officer FD Checklist document**. (from ARRL Website) Provide appropriate security for CARA members, visitors/guests, equipment and assets. Provide signed ARRL FD Safety Officer Affidavit of Compliance to CARA FD Score Submission Team to claim Bonus Points.

## 9. Field Day Bonus points:


Refer to the ARRL 2024 FD Rules & determine which bonus points to complete the requirements for. Provide the ways and means to execute tasks to earn these bonus points. Includes creating and sending the CARA FD message to the ARRL CT Section Manager, creating and handling formal NTS (National Traffic System) traffic (maximum of 10 messages) via the FD station(s) during the event. Making satellite QSO. Writing and distributing the CARA FD Press Release – inviting the media to attend and cover the event. Setting up a CARA FD Social Media Facebook page and uploading content (primarily photos) during the event.

## 10. CARA 2024 FD Score and Bonus points submission, Report preparation

Review the FD log. Compile the N1MM+ log from logging computers. Gather required evidence (documentation/photos) to support claimed bonus points. Submit score, plus claimed bonus points evidence to ARRL via ARRL Web application. Prepare and submit *CARA Field Day Report* to Capers Editor to be published in the CARA Capers Monthly newsletter.
