

The Regular Meeting of the Holiday Lake Rural Improvement Zone Trustees held a meeting at 6:00 P.M. on Wednesday, May 4th, 2022, at the Holiday Lake Community Center, Lakeshore Drive.

The meeting was called to order at 6:03 pm by President, Brad Storm.

Brad Storm went into detail on how to read the Riz financial report so that the new lake board members could understand how it all works for the Riz Trustees.

The Riz trustees discussed dredging the lake this year. They discussed what was discussed with the engineering company that is helping with this process and what is being planned.
