something.

Pat then asked about slit basin prep. If there was anything they needed from the Lake Board when it comes to that. Tom Dvorsky stated that they have one basin that they would like to go look at, but hopefully they know more in the next couple of weeks what they will need after meeting with an engineer for dredging.

Tom Dvorsky then started to discuss the Dredging that will hopefully be happening in the near future. Rick Happe handed out a few items that shows the process they are working on and reviewed it with

everyone.

Deb Mills asked if we knew when Brad would start doing water testing on the lake. Riz trustees discussed what information they had as to when they thought Brad use to do the testing.

As there being no further business to come before the Trustees, President Tom Dvorsky adjourned the meeting at 6:48 P.M. Josh Giannetto moved to approve and seconded by Tom Hinders. Motion carried by a unanimous voice vote.
