The majority of patients pay for their NHS ophthalmic treatment so if you are claiming help with health costs, it is your responsibility to check that you are entitled before you declare that you do not have to pay. Routine checks are carried out by the Business Services Organisation. If you claim free treatment that you are not entitled to, you could face penalty charges of up to £150, in addition to the original treatment charge. It is therefore in your best interest to claim correctly.

Who is entitled?

You are entitled to free or reduced cost treatment if you :

| \checkmark | are entitled to or named on a valid NHS Tax Credit Exemption Certificate | \checkmark | have been prescribed complex lenses |

| \checkmark | are entitled to or named on a valid NHS Tax Credit Exemption Certificate | \checkmark | are diagnosed as having glaucoma |
| \checkmark | are named on a valid HC2 Certificate | \checkmark | are aged 40 or over and have a parent, brother, sister, son or daughter with glaucoma |
| \checkmark | are named on a valid HC3 Certificate (offering partial assistance with charges) | \checkmark | are registered blind or partially sighted |
