DEPOSIT & PAYMENT TERMS

All deposits are non-refundable and required to secure the date of the event, in addition to all personnel and supplies needed. A 20% deposit for the total amount of the Invoice is due upon Event Contract signing. Deposits are accepted via Cash, Venmo, Zelle or CheddarUp payment. Invoices are processed through our parent agency, Johntry Appleseed LLC. Event balances are due upon the event's end. Late payments that are submitted after 24 hours of the event's end are subject to a Late fee of an additional 10% from the total invoice.

CANCELLATION POLICY

Events must be cancelled at least one week (7 business days) in advance, before a Cancellation fee of \$100 is billed. All deposits are non-refundable, as they are required to secure the date of the event, as well as the necessary personnel and supplies needed in planning. If you wish to re-schedule your event instead of cancelling, arrangements must be made at least one week prior. There is no guarantee that the amended date of choice will be available for a re-scheduled booking.

SETUP & BREAKDOWN

The Appleseed: FacesSM/ F.A.C.E. Painting EnterprisesSM party team typically needs between 30 minutes to two hours to set up the event space, depending on the amount of decorations or additional activities planned. It is the responsibility of the client to ensure that our party team will have access to the event space, and coordinate with the venue ahead of time, to ensure the proper setup or unloading and breakdown or loading of event materials, as agreed. Use of equipment during setup or breakdown is strictly for F.A.C.E. personnel, and the company shall not be held liable in the event that any additional persons are affected or injured in the manner of assisting the party team on their own voluntary accord.

SUPERVISION

It is expected that the event will be secured with the necessary amount of adult supervision for all children under the age of 18. LIABILITY WAIVER

As stated in our Health & Safety Disclaimer (attached), all materials are non-toxic and safe for bodily use. If a guest is typically subject to allergic reactions or is concerned about after-effects, it is suggested that a skin test is performed wherein a small test area is exposed to the desired paint for fifteen minutes before use. In removing all painted artwork, basic soap and water or wipes for sensitive skin are sufficient for removal. Henna designs will fade, but can last up to three weeks with proper drying care. Upon entering this Event Contract, the Client waives all liability on behalf of any event attendees concerning any allergic reactions or medical repercussions that are caused by the use of Face/Body paints or Henna design materials.

Although our products are hypoallergenic and non-toxic, allergic reactions may occur on rare occasions or on clients with sensitive skin. Any itching, burning rash, or breakouts that occur after the services are performed are accepted at the client's own risk. If a person has never been painted before or has sensitive skin, a patch test may be performed to determine skin sensitivity. If there is no

reaction after 15 minutes' time, it is likely that no long-term reactions may occur. It is advised that if any discomfort is felt after services are performed, our products can be removed with a wet towel.
