TECHNICAL CORRECTIVE AMENDMENT TO THE DECLARATION OF EASEMENTS, COVENANTS AND RESTRICTIONS FOR THE VILLAGE OF VALLEYBROOK

THIS TECHNICAL CORRECTIVE AMENDMENT to the Declaration of Easements, Covenants and Restrictions for the Village of Valleybrook is dated this ______ day of _______ 2023.

WHEREAS, the Valleybrook Homeowners' Association, Inc. (the "Association") is governed by the Declaration of Easements, Covenants and Restrictions for the Village of Valleybrook, dated October 8, 1974 and recorded in the Delaware County Recorder of Deeds Office on November 4, 1974, in Deed Book 2519, Page 933, et seq., as amended (the "Declaration"), the Bylaws of Valleybrook Homeowners' Association, Inc., as amended (the "Bylaws"), the Rules & Regulations ("Rules & Regulations") (collectively, the "Governing Documents") as well as the Pennsylvania Uniform Planned Community Act, 68 Pa. C.S.A. §§ 5101, et seq. (the "Act");

WHEREAS, pursuant to Section 5219(f) of the Act, "...if any amendment to the declaration is necessary in the judgment of the executive board to...cure an ambiguity...correct or supplement any provision of the declaration...that is defective, missing or inconsistent with any other provision of the declaration or with this subpart...then, at any time, the executive board may, at its discretion, effect an appropriate corrective amendment without the approval of the unit owners...upon receipt of an opinion from legal counsel who is independent from the declarant to the effect that the proposed amendment is permitted by the terms of this subsection.";

WHEREAS, pursuant to Section 5302(a)(2) of the Act, the Association is authorized to, "...[a]dopt and amend budgets for revenues, expenditures and reserves and collect assessments for common expenses from unit owners.";

WHEREAS, pursuant to Section 5314(a) of the Act, "... assessments shall be made at least annually, based on a budget adopted at least annually by the association (emphasis added).";

WHEREAS, pursuant to Section 5307(a) of the Act, "... the association is responsible for maintenance, repair and replacement of the common elements...[.]";

WHEREAS, pursuant to Section 5303(a) of the Act, "...the executive board may act in all instances on behalf of the association. In the performance of their duties, the officers and members of the executive board shall stand in a fiduciary relation to the association and shall perform their duties...in good faith; in a manner they reasonably believe to be in the best interests of the association[.]";

WHEREAS, Article V, Section 5 of the Declaration currently prohibits the Association's Board of Directors (the "Board") from increasing or otherwise altering the amount of the Association's Annual Assessments without the affirmative vote of at least two-thirds (or 67%) of the Unit Owners, regardless of whether or not any such change is necessitated by the Annual Budget;

WHEREAS, the Association's Board has determined that it is unable to comply with its fiduciary obligation to adequately maintain, repair and/or replace the Association's Common Elements, nor is the Board able to prepare and comply with an accurate Annual Budget of the Association, due to the restrictions imposed by Article V, Section 5 of the Declaration;

WHEREAS, the Board has determined that a Technical Corrective Amendment to Article V, Section 5 of the Declaration is appropriate and necessary in order to enable the Board to comply with its fiduciary obligation to administer the Association and adequately maintain, repair and/or replace the Association's Common Elements; and

WHEREAS, the Board has received an opinion from independent legal counsel that such proposed Technical Corrective Amendment is consistent with Section 5219(f) of the Act.

NOW, THEREFORE, intending to be legally bound, the Association, through its duly elected Board of Directors, hereby amends the Declaration as follows:

- 1. Article V, Section 5 of the Declaration is hereby deleted in its entirety and replaced with the following revised Article V, Section 5:
 - "Section 5. Change in basis and Maximum of Annual Assessments. The amount and basis of the Annual Assessments contemplated herein may be adjusted by the Association, acting through the Board, with any such adjustments being computed on an annual basis based upon amounts established in the Annual Budget prepared by the Board of Directors. The adoption of the Association's Annual Budget, as well as any corresponding adjustments to the Annual Assessments, shall be subject to the terms of Section 5303(b) of the Pennsylvania Uniform Planned Community Act, 68 PA C.S.A. §5101, et seq. (the "Act"). It is the responsibility of the Owners to pay all Annual Assessments levied by the Association."
- 2. All other provisions within the Declaration that are not specifically altered by the above shall remain in full force and effect.
