WELCOME BACK!

June 30, 2020 marked the end of the first fiscal year of our evidence based home visiting expansion grant. This grant provided the platform for four county collaboration as First Steps Central MN.

COVID 19

Several Public Health Nurses and staff were also pulled into the COVID-19 emergency preparedness response. Common themes that have been important during this time include flexibility, patience, learning, and grace. Incoming referrals have remained steady despite COVID-19.

Based on guidance by MDH, our evidence based models, and individual county administration teams, local public health agencies have been providing family home visiting (FHV) in creative ways during COVID-19.

While the Public Health Nurses aren't currently physically going into the homes of enrolled families, they are offering the same support, education, and connection to resources that they always have. Their creativity and commitment to the families in our communities has been exceptional.

Our Nurses continue to have regular contact with families, including phone and video calls, text messages, emails, and door drop-off bags to engage and enroll new families into programming and to help retain families already connected with a Personal Nurse.

Door drop-off bags included a variety of materials, including resource information, educational materials for upcoming home visits, FHV newsletters, and/or family support supplies like board books, self-care encouragement items, or milestone toys.

A weekly newsletter was developed during this season as well. PHNs have used it as an engagement and retention tool for new referrals and enrolled families alike. Beginning in August 2020, these newsletters will shift to monthly publications. You may access them on our <u>First Steps Central MN</u> <u>website</u>.

We recognize that times of high stress and uncertainty may actually increase the need for families needing a Personal Nurse. We are still accepting new referrals and enrolling new families. We thank you for connecting families to us!



FIRST STEPS CENTRAL MN

is a team of registered nurses from Benton, Sherburne, Stearns, and Wright County Public Health who offer free support, advice and information to have a healthy pregnancy, a healthy baby, and be a great parent by providing free, voluntary in-home family home visiting services utilizing evidencebased programming to eligible families. The evidence-based programs we offer are Nurse Family Partnership and Healthy Families America.

Our nurses help promote healthy birth outcomes and positive parent-infant relationships, encourage healthy growth and development for infants and young children, prevent complications of illness and chronic disease conditions, promote healthy and safe environments, and encourage family self-sufficiency and linkage to community resources.

FAMILY IMPACT STORIES

One of our PHNs is working with a Mom who had two children removed from her custody in the past. During a subsequent pregnancy, Mom started working with an HFA PHN, was connected with a treatment program, and has successfully stayed sober and out of Child Protection Services for 2 years. She often tells her PHN that she credits her commitment to weekly visits with the PHN to helping her get and stay sober. This client has maintained a steady job for over a year and no longer needs the support of public financial assistance. Through COVID, she has continued weekly telehealth visits and continues to succeed.

One of our NFP PHNs started working with client at 16 weeks gestation. Mom has a diagnosis of Dissociative Identity Disorder, Anxiety, and Depression. Mom has had numerous mental health hospitalizations related to suicidal ideations. Mom also has a history of childhood abuse - emotional and sexual. Father of baby was in foster care his whole childhood due to caregiver neglect. Father has a significant criminal history and continue to be monitored by the criminal justice system. Mom was interested in having a Personal Nurse because she wanted to learn information about her pregnancy and parenting. She is a first-time mom and has not experienced any of this before. Her PHN was able to provide education to both Mom and Dad during pregnancy. This education included baby cares and attachment. Both Mom and Dad were engaged in education and asked many questions. Currently, baby is 6 months old and reaching all of her developmental and growth milestones. Mom and Dad have shown to be bonded and attached to baby and report a satisfaction in their life that they have never experienced before. They report this satisfaction is related to baby. According to Dad, baby has given purpose to their life. Mom's PHQ-9 (mental health assessment) and GAD-7 (anxiety assessment) scores are significantly lower now, which she attributes to the joy that baby brings.

One of our NFP PHNs is working with a mom who was hooked on multiple drugs when she found out she was pregnant. During that time, mom had unstable housing and was couchhopping with friends. Over the course of working with her Personal Nurse in the NFP program, Mom became sober, graduated high school and is enrolled in college for nursing. She lives in a low income apartment with her child. Mom is currently working as a Certified Nursing Assistant (CNA) and her child is in daycare. Mom said that she could not have done any of it without NFP and the support, goal setting, and help with resources provided by her Personal Nurse.

FOCUS POPULATIONS

- Pregnant or within 3 months postpartum
- Low income (WIC or MA eligible)
- Live in Benton, Sherburne, Stearns or Wright County

Identified areas of concerns for families may include (but are not limited to):

financial or housing insecurities

- infant feeding support
- limited support system,
- limited parenting skills
- late prenatal care or poor compliance
- history of or current abuse, safety concerns, violence, mental health concerns, chemical or tobacco use or abuse

Referring partners don't have to decide which program, just refer and our staff will connect families with the program that will best fit their needs.

To make a referral, first talk to families and get their permission. Then either download our referral form online to fax in to 763-765-4250 or give us a call at 763-276-0441.

A family can expect an initial contact within 1-3 business days.


FIRST STEPS CENTRAL MN - REFERRALS BY FAMILY RESIDENC 2020-02





Partnership with CentraCare Health--Epic Care Link

On August 17,2020 the Epic Care Link will begin its pilot within CentraCare - Plaza Clinic Obstetrics & Women's Health. The Epic Care Link will help connect prenatal patients to family home visiting services in a new way. Epic will flag providers if a patient has an identified risk factor for family home visiting. If a patient agrees to have a follow-up call from a Personal Nurse to learn more, the provider simply clicks a button in the Epic system to generate a referral to First Steps Central MN. We look forward to rolling out the Epic Care Link to additional CentraCare services, clinic locations, and the inpatient setting in the future.
