Sherburne: Focused on building WIC prenatal referrals in 2025, maintaining and maximizing revenue from third party billing (MA/PMAPs). Promising Practices grant which funds Community Health Worker; pilot going well, increasing family engagement and caseload growth for Spanish-speaking families. Continued support to Family Resource Center work happening across the community with several locations. In broader HHS, new Therapeutic Services Unit to help fill the gaps for families and their therapy needs; in response to long therapy waitlists in the community for families. c. Stearns: Recruiting for open PHN position. Adjusting program workloads for FHV staff. Working to expand WIC accessibility, especially to Hispanic/Latinx communities. Continue to support FRC work happening in the community and partnerships with Community Schools within ISD 742. d. Wright: Maintaining revenue, caseloads, and outreach workplan activities. Diversifying caseloads with evidence-based programming and Traditional (short-term). Expanding Supporting Steps program where a licensed alcohol and drug counselor partners with FHV PHN in supporting FHV families who have history of or current substance misuse concerns.
