Dear Beef Customer,

Enclosed you will find a copy of the "Sale of Beef Contract". Since cattle prices have increased significantly and feed costs have remained steady, we are raising the price of our beef to \$4.50/# hanging weight. We have reservations for beef at Country Pride Processing and plenty of calves this year, but please return your contracts to us as soon as possible as we will be selling the calves which were not spoken for early in 2026.

As in the past, you have the option of either paying a deposit for your beef now (Option 1) with the balance being due in full while it is being processed; **or** paying for it in installments for 10 months (Options 2 or 3) with the remaining balance due while it is being processed in the summer of 2026. The installment options (Options 2 or 3) will allow you to receive a 5% discount on the full price of your beef. If you have an email address, please include it on your contract so I can send out updates and payment reminders-especially for those of you who choose to use Option #3.

Please mark one of the choices in each grouping on the "Sale of Beef Contract" which includes: 1. The amount of beef you want. 2. The month in which you want your beef available to be picked up, and 3. Whether you prefer payment Option #1, #2 or #3.

Lastly, return the SALE OF BEEF CONTRACT to us by <u>October 1, 2025</u> along with a check for the amount of deposit <u>or</u> the first payment and fill out the enclosed receipt for your records. <u>Please</u> make sure that we receive your beef payment on or before <u>1st of each month</u> so that we have the funds available for the feed bill and in turn, with the interest we save, we are then able to reimburse you the 5% discount. If you are having the check sent directly from your bank, please allow for processing and mailing time. You can also Venmo it to: Connie-Hansen-32.
