PARENTAL CONSENT FORM

(This form MUST be signed by the minor's legal parent or guardian)

Minors may participate at Jamaica Esports Initiative (the "JEI") events (the "Event"), including the tournaments and any related events (e.g., meals, practices, registration, etc.) with the signed consent of the child's (the "Minor") parent or legal guardian ("Parent/Guardian"). If a participant or spectator is under 17 years of age, he/she is considered a minor and must submit this consent form, signed by a parent or legal guardian, upon entry to the event.

Minors Under 16

Participants and spectators under the age of 16 must be accompanied by their parent, legal guardian or a designated adult (18 years of age or older) at all times during the event. Minors under the age of 12 may not be left under the Supervision of event staff at any time.

Consent to Attendance and Participation

The event is a video game tournament where an entry fee may be charged and cash and other prizes may be awarded to certain winners. Although the Event may feature games rated "E" for Everyone, the Parent/Guardian further understands that the event may feature video game competitions featuring one or more video games that have ratings of "E10+" for Everyone 10+, "T" for Teen and "M" for Mature, and that these ratings indicate that the content of the video games have been deemed unsuitable for children under the age of 17 years.

Assumption of Responsibility

The Parent/Guardian assumes all responsibility and liability for any and all damage and injury suffered by/to or caused by/to the Minor while at the Event or any areas surrounding the Event.

Release
