Re: Information about the Hiawatha East Bankruptcy Case

Dear Hiawatha East Interval Owner,

As many of you know, Hiawatha Manor Association (East) (“**Hiawatha East**”) has filed for bankruptcy. You are receiving this notice because county land records show you may still have an ownership interest – or some remaining responsibility – for a timeshare at Hiawatha East.

Why Hiawatha East filed Chapter 11

On May 6, 2025, Hiawatha East began Chapter 11 Case No. 25-01916 to arrange a single, court-supervised sale of the entire resort, free and clear of all timeshare interests. After the sale closes, the net proceeds will be distributed to current interval owners, minus any unpaid amounts each owner owes the HOA.

What to do on your end

- No action is required on your end.
- At the end of the proceeding, a settlement distribution agent might ask you for a 1099 or other information if funds from the sale of this property are due you.
- If you are not a US resident, we will be reaching out for more details to ensure everything goes smoothly on your end. Please email HiawathaEastReimagined@Lemonjuice.biz to update your telephone and address information.

A creditors’ meeting (“§ 341”) will be held June 3, 2025, at 1:30 p.m. Central by telephone (see bankruptcy notice). Most owners are not creditors, but we are required to inform

For the debtor listed above, a case has been filed under chapter 11 of the Bankruptcy Code. An order for relief has been entered.

The filing of the case imposed an automatic stay against most collection activities. This means that creditors generally may not take action to collect debts from the debtor or the debtor's property. **COMPLAINT TO SELL ESTATE'S INTEREST AND CO-OWNERS' INTERESTS IN
REAL PROPERTY PURSUANT TO 11 U.S.C. § 363(h)
(HIAWATHA EAST)**

Hiawatha Manor Association, Inc. (the “*Debtor*”) files this complaint pursuant to 11 U.S.C. § 363(h) of the United States Code (the “*Bankruptcy Code*”) and respectfully avers as follows:

PARTIES

1. The Debtor may be served with pleadings and process in this adversary proceeding through its undersigned counsel.
2. There are a total of 1,525 Defendants. A full list of the Defendants and their service addresses are attached to this complaint as **Exhibit A**.

JURISDICTION

3. This Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334.
4. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A), (N), and (O).
5. Venue is proper in this district pursuant to 28 U.S.C. § 1408.

6. The Debtor has complied with Rule 7001(3) of the Federal Rules of Bankruptcy Procedure, which requires a debtor to file an adversary proceeding in order to sell a non-debtor, co-owner's interest in property pursuant to 11 U.S.C. § 363(h).

BRIEF STATEMENT OF THE CASE

7. The Debtor owns interests in the Units (as defined below) as a tenant in common, pursuant to Tennessee law. *See Sevier Cnty. v. Tenn. State Bd. of Equalization*, No. E2022-00773-COA-R3-CV, 2023 WL 3298375, at *4 (Tenn. Ct. App. Feb. 14, 2023) (stating timeshare interests are sold to persons as undivided fractional interests as a tenant in common for specified units); T.C.A. § 66-32-103.

8. The Debtor files this complaint in order to obtain declaratory relief that it may sell the entire Property (as defined below), including the non-debtor, co-owners' interests, pursuant to 11 U.S.C. § 363(h).

9. The Debtor intends to file a motion in the main bankruptcy case seeking approval of the private sale of the Units and Property (each as defined below) free and clear of all liens, claims, encumbrances, and interests pursuant to 11 U.S.C. § 363(f).

STATEMENT OF FACTS

10. The Debtor is a Tennessee non-profit corporation and the condominium owners association of that certain 47-unit (each a "*Unit*" and collectively, the "*Units*") development located at 8005 Cherokee Trail, Crossville, Tennessee 38572, which is commonly known as the Hiawatha Manor Resort (the "*Property*").

11. Tansi Resort, Inc., a Tennessee corporation, submitted the Property to condominium ownership and registered the Property as an "Interval Ownership" timeshare condominium under (a) that certain Declaration of Horizontal Property Regime Master Deed, Hiawatha Manor, Lake Tansi Village, Crossville, Tennessee, dated as of July 11, 1979, and (b) that

certain Declaration of Horizontal Property Regime Master Deed, Hiawatha Manor I, Lake Tansi Village, Crossville, Tennessee, dated as of October 27, 1980.

12. The Debtor is the owner of 1,764 undivided fractional interests as a tenant in common with one or more of the Defendants in each of the Units at the Property.

13. On February 24, 2025 and March 10, 2025, the Debtor convened separate meetings with the current owners of the time share interests in an attempt to terminate interval ownership of the Units by way of a vote.

14. The votes failed in both instances due to the Debtor's inability to gather a sufficient quorum of current owners of the time share interests to meet the requisite voting threshold, which has led the Debtor to seek equitable relief from this Court to terminate the interval ownership of the Units.

15. Regardless of the failure of the vote, the Debtor owns its interests in the Units as a tenant in common with Defendants.

16. As a result, the Debtor owns certain portions of the Property as a tenant in common with not less than one thousand five hundred (1,500) individuals, trusts, and corporations, with each interest entitling the co-owner to a fixed week of occupancy akin to a timeshare association.

17. In addition to the co-tenants, title work conducted by the Debtor in anticipation of a sale of the Property has revealed approximately one hundred ninety-eight (198) additional individuals or entities that appear in the title chain records for the Property, but which do not hold any valid legal or equitable interest in the Units or Property (such individuals or entities, "*Clouders*").

18. Although the Clouders do not have valid ownership interests in the Units or Property, the Debtor has included them as Defendants to ensure all parties with alleged or asserted

interests in the Property are provided notice of the sale of the Property free and clear of the Defendants' interests.

19. Many of the tenants in common have either walked away from their ownership and stopped paying maintenance fees or transferred their interests to timeshare relief companies.

20. As a result, many of the tenants in common (and all of the timeshare relief companies) fail to pay maintenance fees, resulting in the incurrence of statutory liens against the interests of the delinquent tenants in common.

21. Income generated by the Property is not sufficient to cover the Property's monthly operating and maintenance costs and other expenses (i.e., taxes).

22. The Debtor desires to sell the entirety of the Property, including the interests of the Defendants, free and clear of all claims, interests, and encumbrances pursuant to 11 U.S.C. § 363(f) and (h).

REQUEST FOR DECLARATORY RELIEF

23. The Debtor requests the Court enter declaratory relief providing that the Debtor may sell the non-debtor, co-owners' interests in the Units and Property pursuant to 11 U.S.C. § 363(h).

24. Section 363(h) of the Bankruptcy Code allows the Debtor to sell a non-debtor, co-owner's interest in property if the following requirements are satisfied:

- a. Partition in kind of such property among the estate and such co-owners is impracticable;
- b. Sale of the estate's undivided interest in such property would realize significantly less for the estate than sale of such property free of interests of such co-owners;
- c. The benefit to the estate of a sale of such property free of interest of co-owners outweighs the detriment, if any, to such co-owners; and
- d. Such property is not used in the production, transmission, or distribution, for sale, of electric or of natural or synthetic gas for heat, light, or power.

25. Each Unit is a condominium with ownership split amongst 52 weeks, resulting in numerous owners as tenants in common each holding a fractional share for each Unit, all of which co-owners are Defendants in this adversary proceeding.

26. None of the Defendants reside in the Units or otherwise on the Property.

27. Partition in kind of each Unit would be impossible given the highly fractured ownership structure with more than 1,500 tenants in common.

28. The proposed sale of the fee simple interest in each Unit will realize significantly greater benefit to the estate than selling the estate's undivided interest as a tenant in common in each Unit.

29. Given the minimal cash flows at the Property, it likely would not be possible to locate any buyer who would be willing to acquire only the Debtor's undivided interest in the Units.

30. Similarly, it is impractical for the Debtor to continue operating under the current ownership structure or to obtain financing based solely on the Debtor's individual interests.

31. The Defendants' interest in the Property will attach to the sale proceeds, and the Debtor will file a plan of liquidation proposing to distribute the net sale proceeds pursuant to and in accordance with the priorities established by the Bankruptcy Code.

32. No Defendants will be displaced from their home by the proposed sale, and the benefit to the estate outweighs any potential detriment to the Defendants.

33. The Units are residential condominiums and are not used in the production, transmission, or distribution, for sale, of electric energy or of natural or synthetic gas for heat, light, or power.

CONCLUSION

34. Accordingly, the Debtor requests that the Court enter a declaratory judgment finding that the Debtor may sell the entirety of the Property, including the interests held by the

Defendants, pursuant to 11 U.S.C. §363(h) and grant the Debtor other or additional related relief as this Court may deem just or proper.
